

MARKET COMMENTARY

Iron ore stocks across 35 Chinese ports gained 240,000 mt week on week to 136.31 million mt as of September 21 as arrivals to ports in Shandong province and Tangshan grew. Daily average volumes departing those ports fell 48,000 mt to 2.58 million mt as purchasing interest across steel mills weakened after spot prices fell along with DCE prices. Pre-holiday stockpiling is expected to grow volumes departing ports this week.



IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
