However, Tangshan and Handan announced another round of heavy pollution weather warnings, to last from October 31 and November 1. Mill demand drifted lower with support for iron ore prices slowly ebbing away. According to SMM, some mills are relatively pessimistic on steel prices over the next two months and some mills say their current iron ore inventory were enough to last a month. The frequent production limits have reduced the consumption of iron ore and mills have showed no intention for the moment to purchase large quantities of ore.

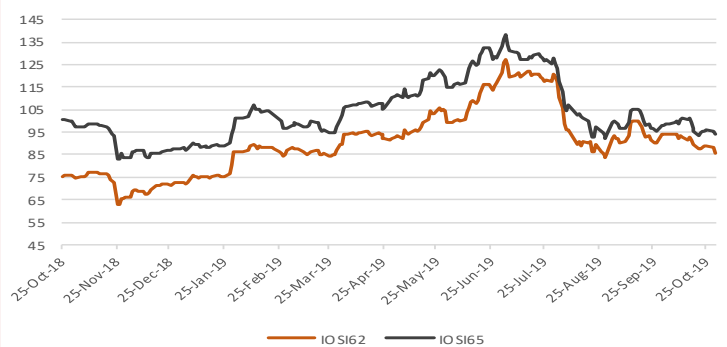

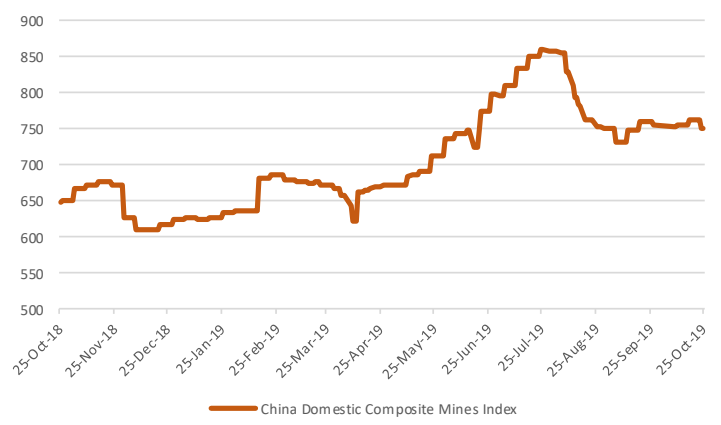

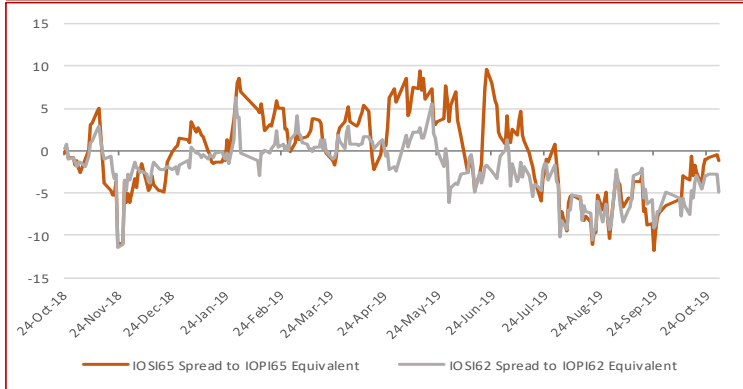

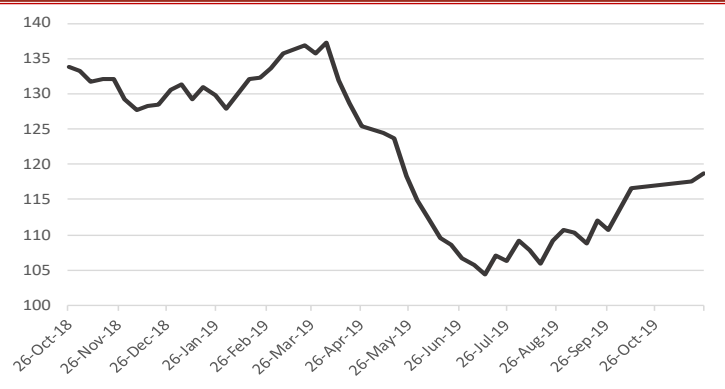
WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



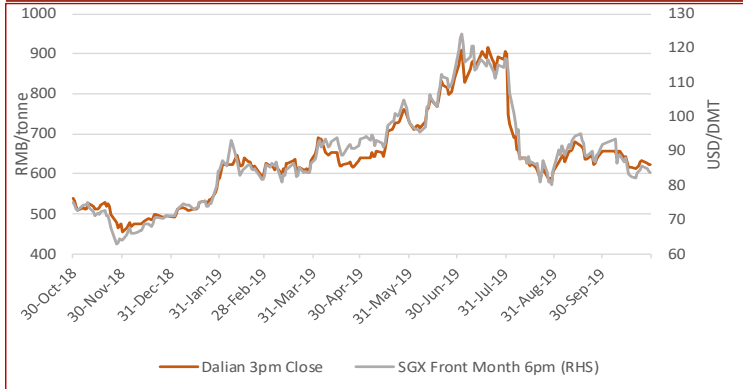
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

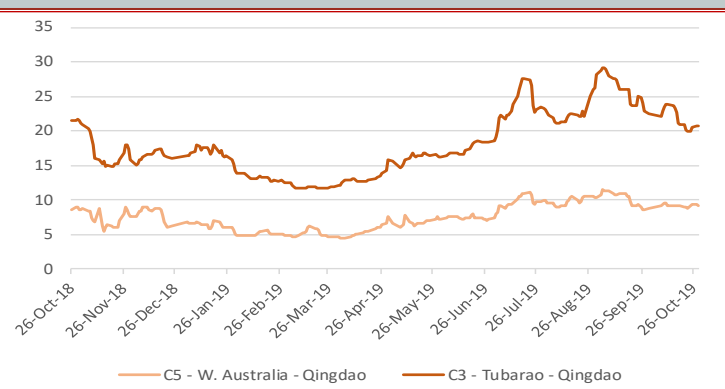

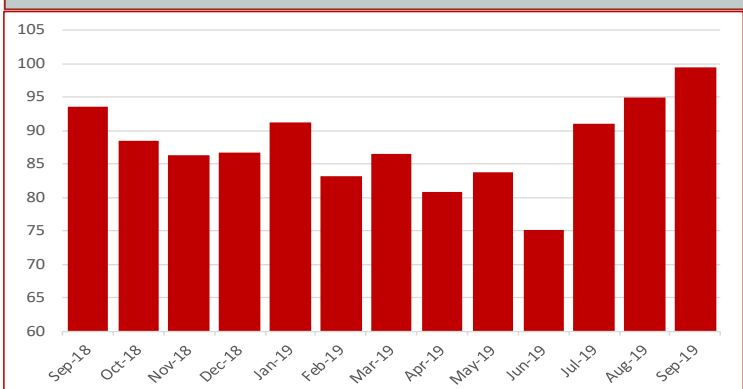

DRY BULK FREIGHT RATES (USD/MT)



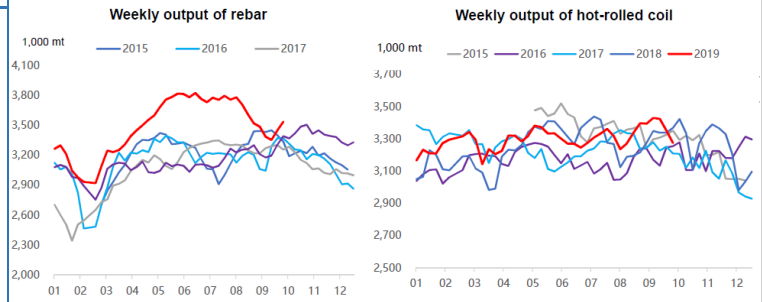
TOTAL CHINA IRON ORE IMPORT VOLUMES (MILLION TONNES)

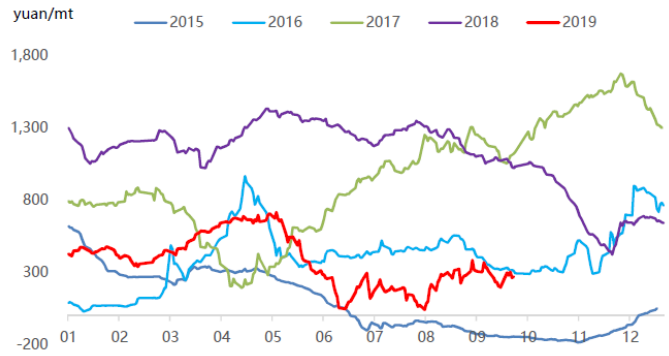

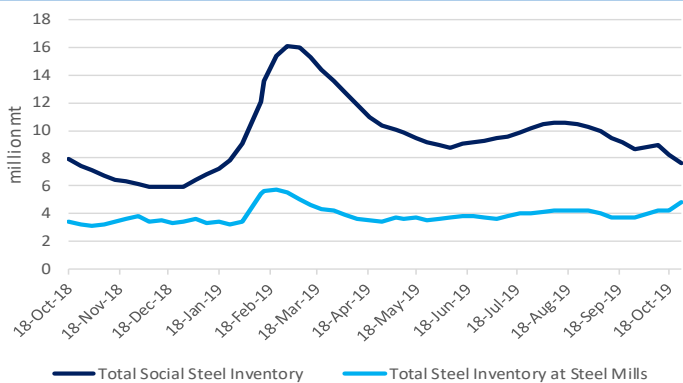

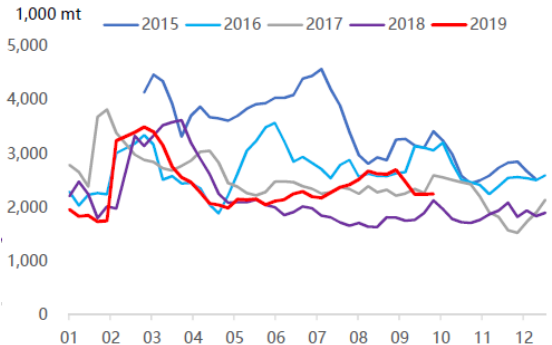

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
