MARKET COMMENTARY

Aug 14th, 2024		CFR Qingdao, USD/dry tonne							DCE iron ore futures continued to decline sharply. The most-traded contract I2501 hit a new low of 706.5 yuan/mt, slightly rebounded in the afternoon, and finally closed at 713 yuan/mt, down 3.32% for the day. Some traders suspended offers; steel mills were cautious and mainly inquired about prices. Overall market transaction sentiment was average today. In Shandong, PB fines traded at 735-740 yuan/mt, down 20-25 yuan/mt from yesterday; in Tangshan, PB fines traded at 745-750 yuan/mt, down 20-25 yuan/mt from yesterday. On August 14, the blast furnace operating rate surveyed by SMM was 91.42%, down 0.95% MoM. The daily pig iron production of sample steel mills was 2.2421 million mt, down 25,100 mt MoM. Pig iron production continued to decline significantly. Meanwhile, market rumors about possible crude steel production cuts in Tangshan heightened market concerns, leading to a sharp drop in iron ore prices. Given the potential rebound in pig iron production next week and the approaching peak season, downstream demand may marginally improve, limiting the downside space for iron ore prices, which are expected to remain weak and volatile.

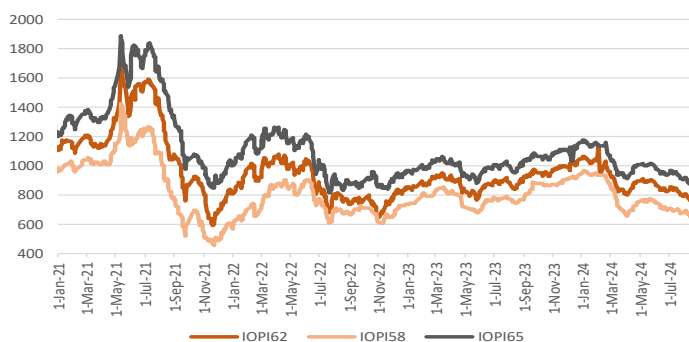

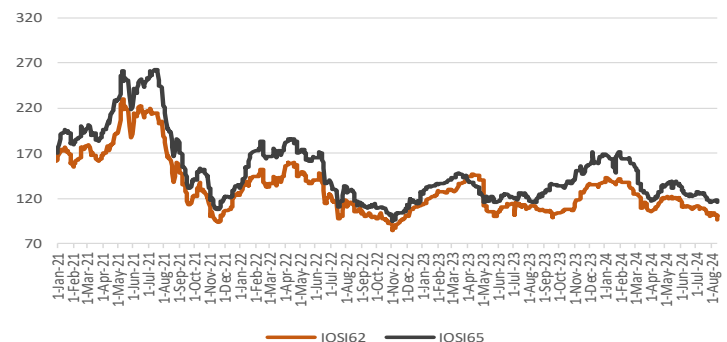

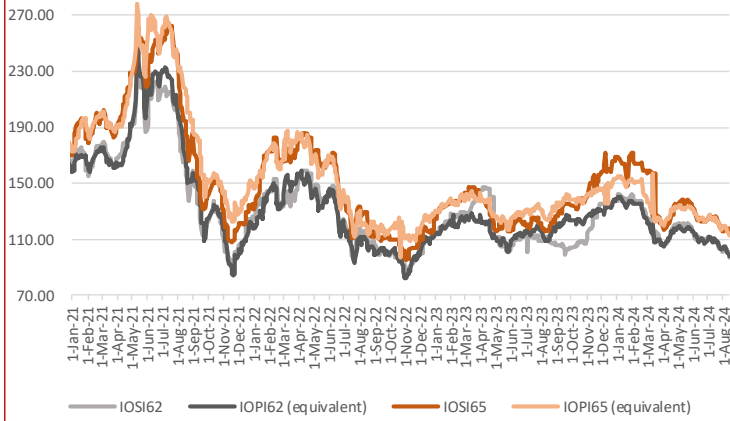

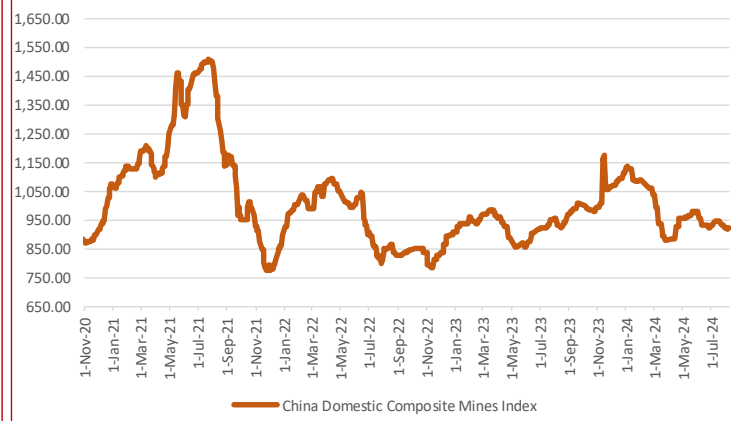

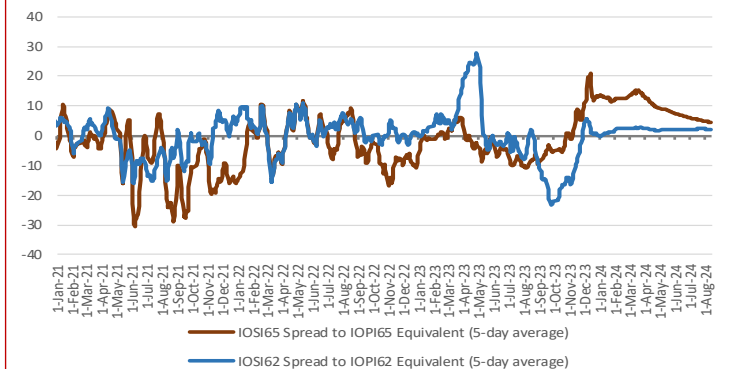

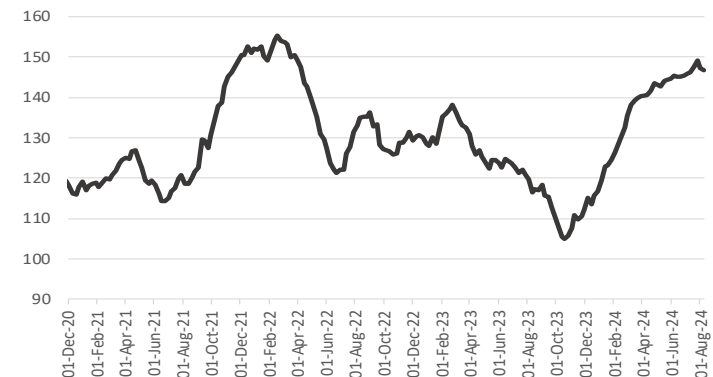
WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



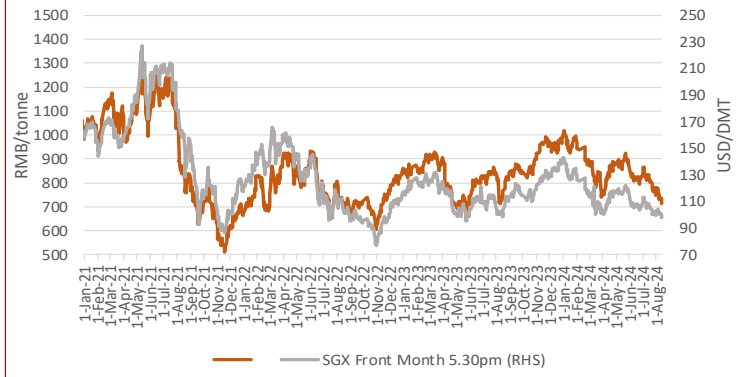
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

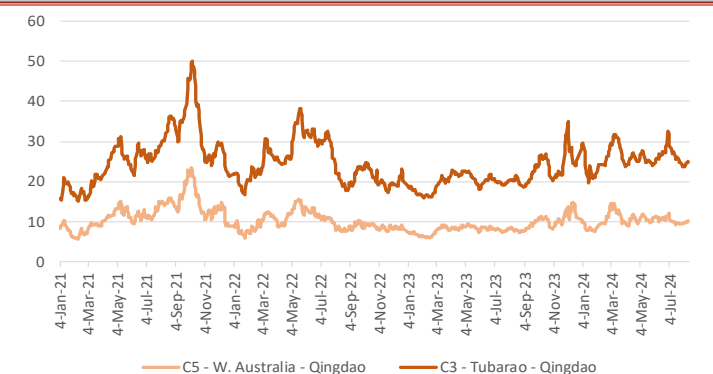

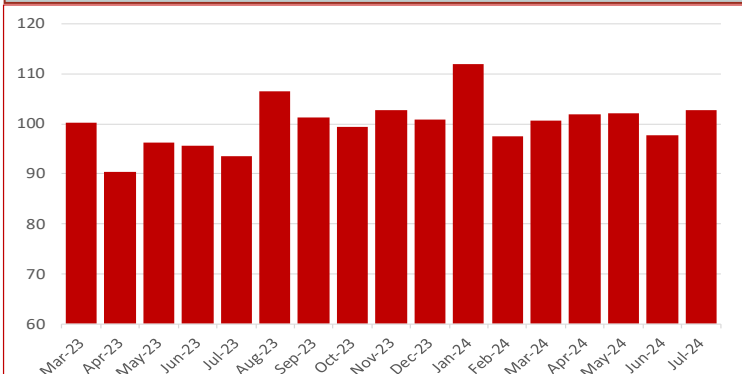

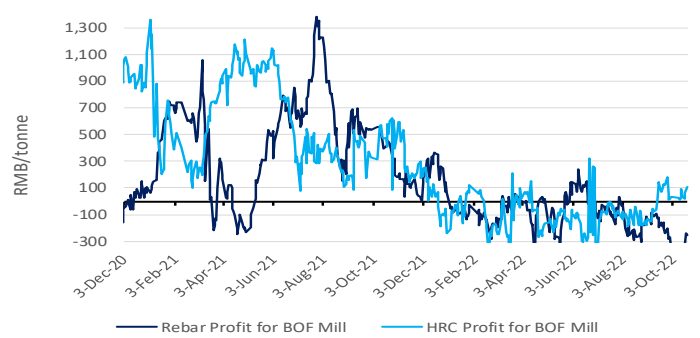

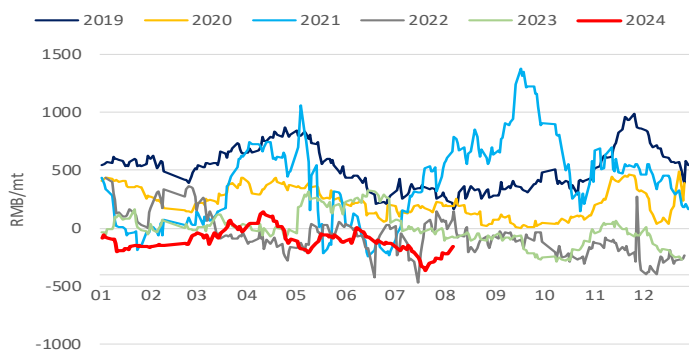

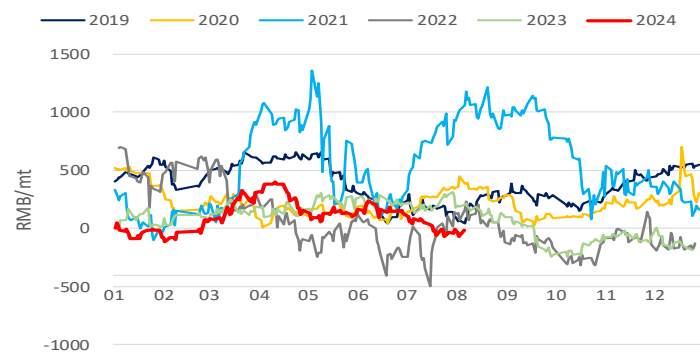
CHINESE STEEL MILL PROFITABILITY



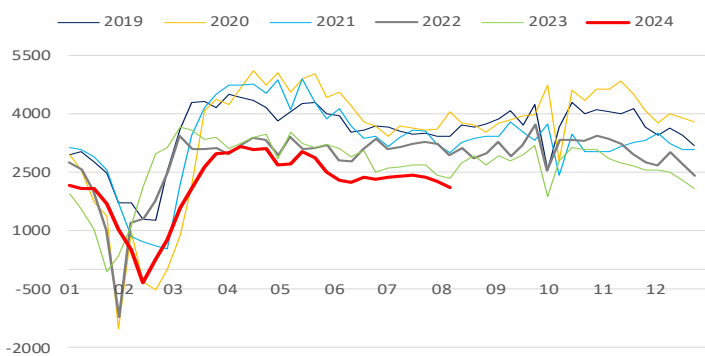
CHINESE STEEL MILL PROFITABILITY—Rebar



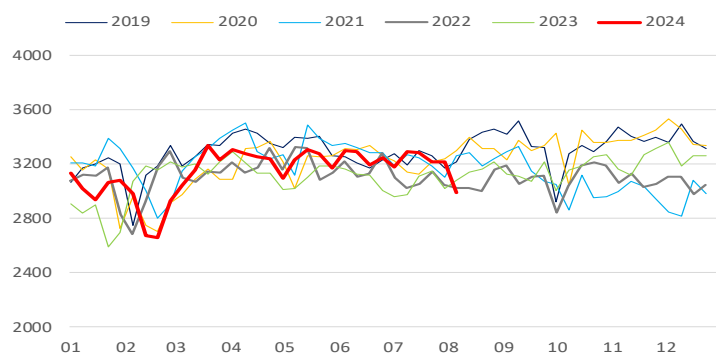
CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



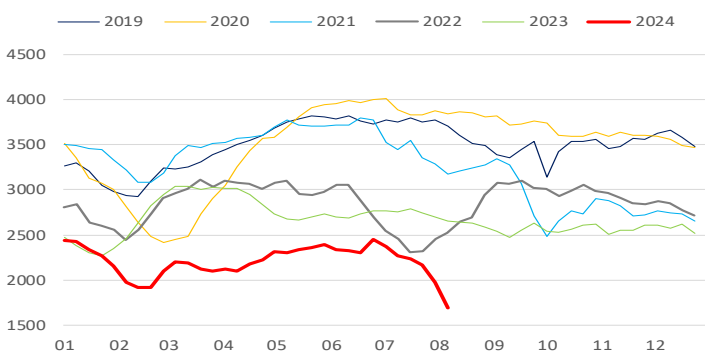
CHINESE STEEL CONSUMPTION—Rebar



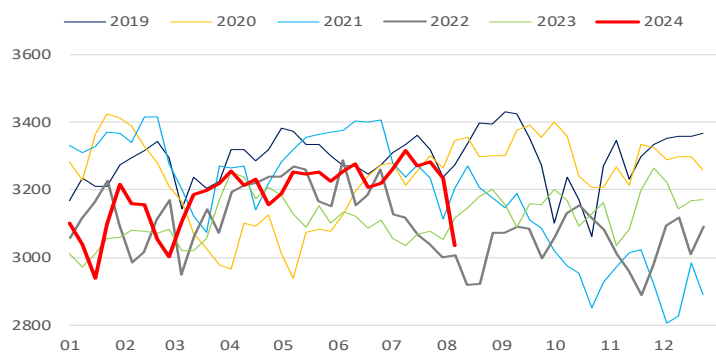

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
