MARKET COMMENTARY

Oct 20th, 2025		CFR Qingdao, USD/dry tonne							On October 20, DCE i2601 Iron Ore Futures Contract closed at 767 yuan/mt, down 0.58% from the previous trading day. Spot cargoes at major ports fell by 1-5 yuan/mt, with PB fines transaction prices in Shandong region ranging between 775-778 yuan/mt, down 1-5 yuan/mt WoW from last Friday, while transaction prices of PB fines at major ports in Hebei region stood at 780-785 yuan/mt, also down 1-5 yuan/mt WoW. Steel mills mainly procured based on demand for restocking, and market trading sentiment remained moderate. Fundamentally, narrowing steel mill profits, coupled with expectations of tighter environmental protection-driven production restrictions in some regions, have strengthened mills' willingness to conduct maintenance, weakening support for iron ore demand. Supply side, both shipments and port arrivals increased significantly this week, and supply is expected to remain relatively ample in the near term. In the short term, with fundamental support weakening, iron ore prices are projected to fluctuate.

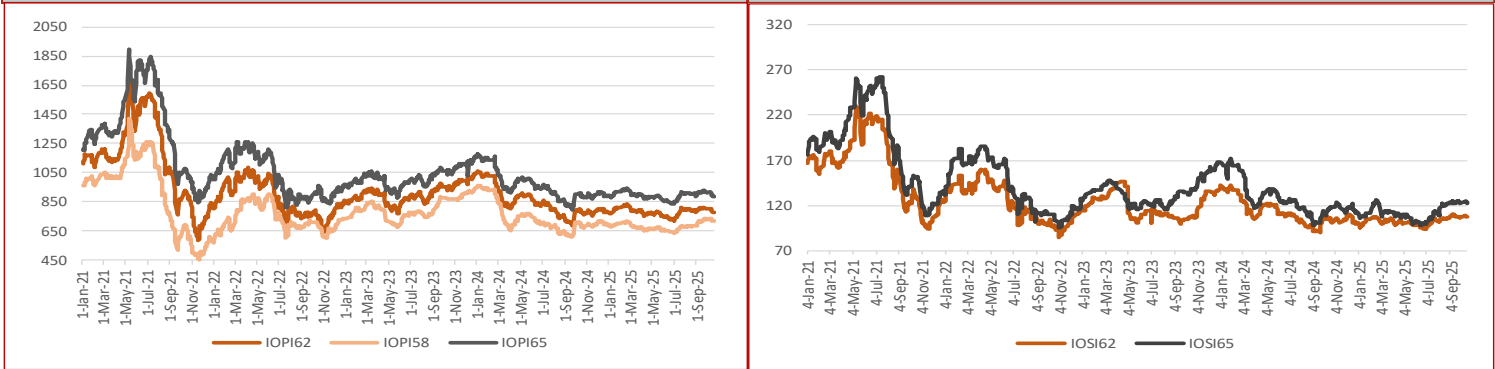

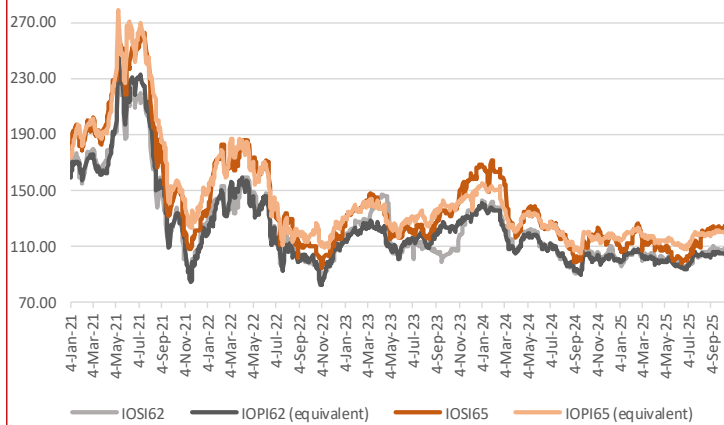

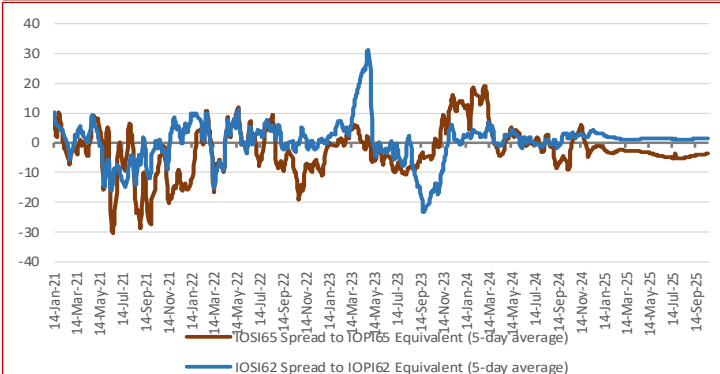

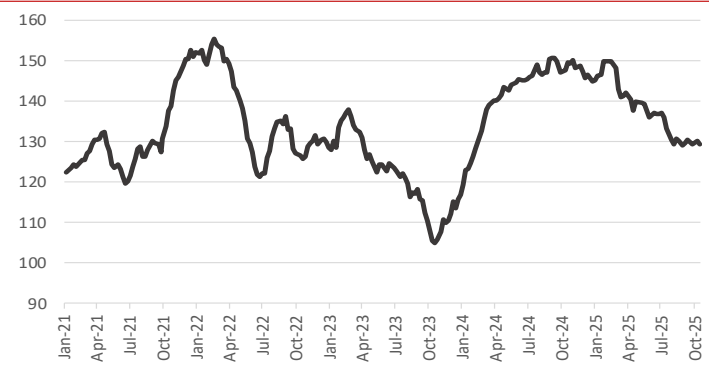
WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



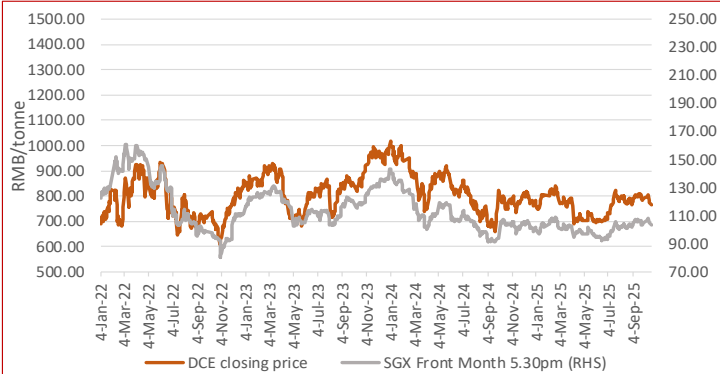
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

FUTURE TRADING—FRONT MONTH CLOSING PRICE



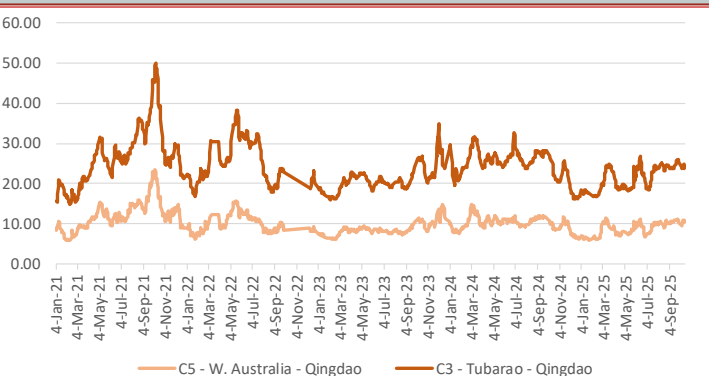

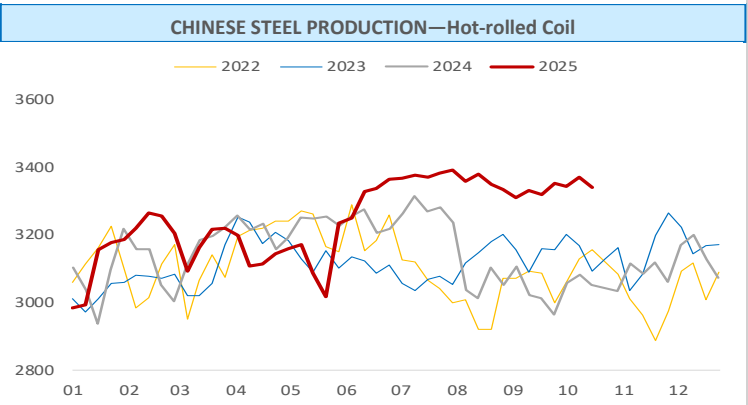
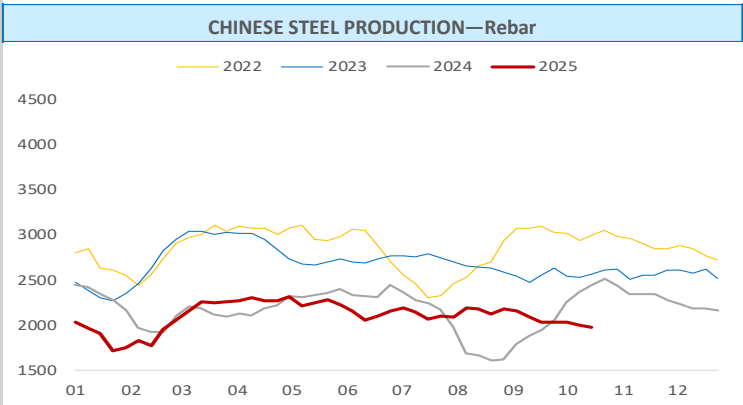
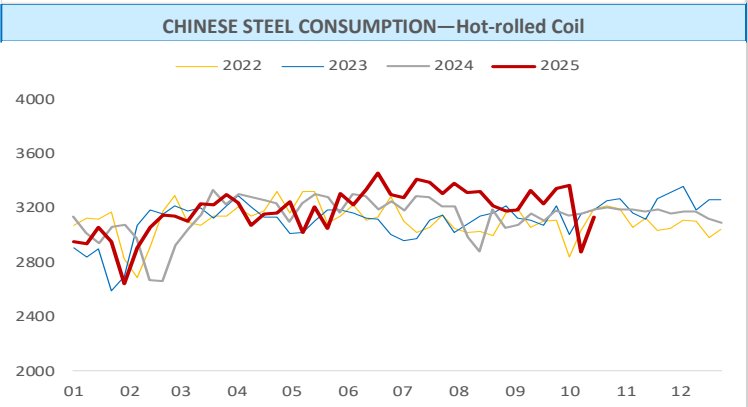
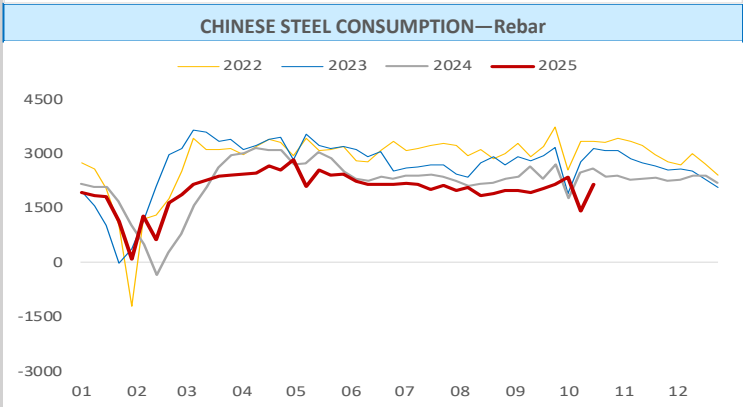
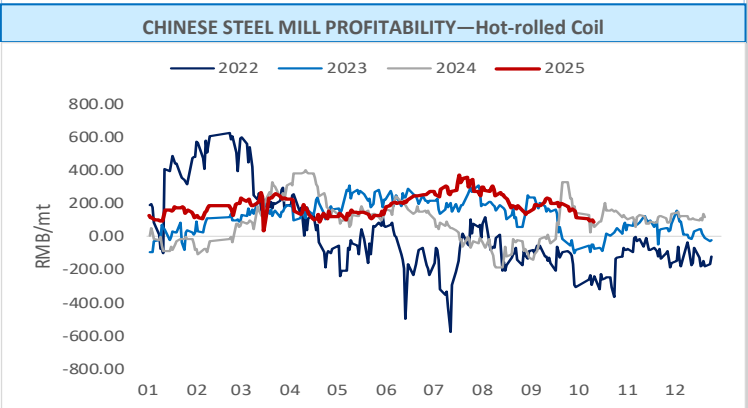
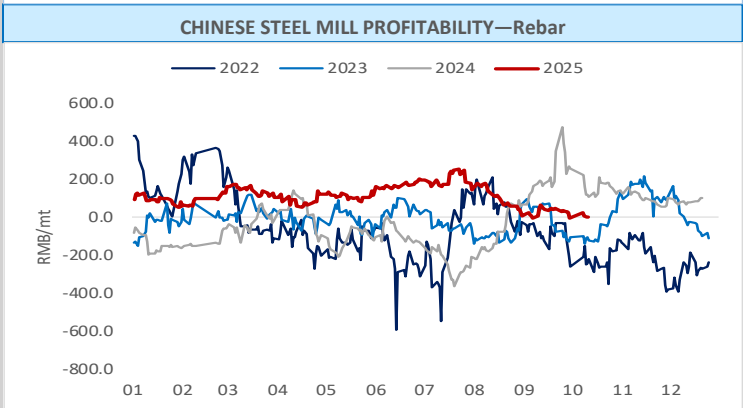
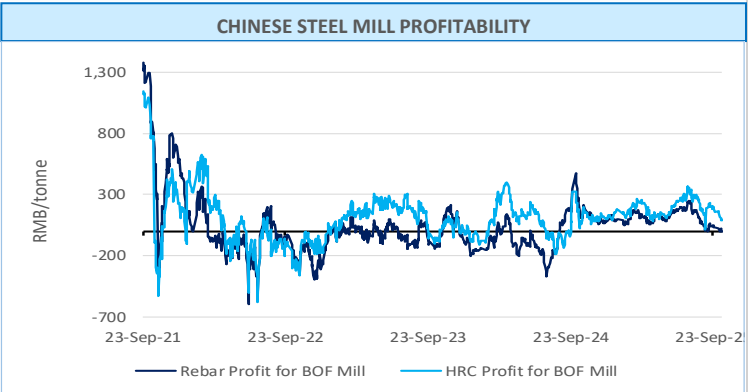
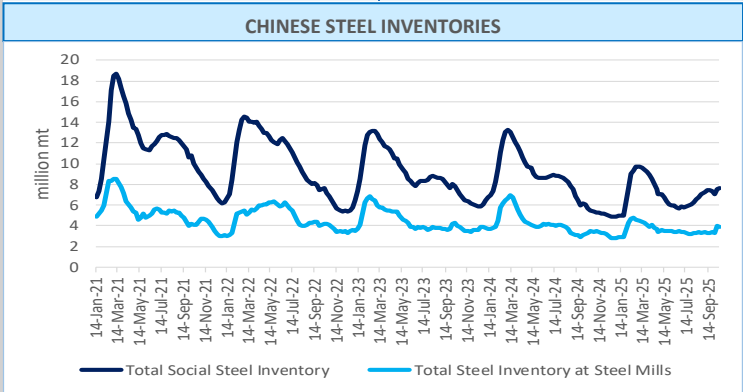
TOTAL CHINA IRON ORE IMPORT VOLUMES (MILLION TONNES)

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
