| May 15th, 2025 |              | CFR Qingdao, USD/dry tonne |        |          |        |        |                  |                   | <div>Today, DCE iron ore futures fluctuated rangebound, weakening slightly in the afternoon. The most-traded contract I2509 eventually closed at 736.5, up 1.17% for the day. Traders sold goods according to market conditions. Some steel mills faced poor sales of finished products, leading to weakened purchase willingness. The market transaction atmosphere was average. In the Shandong region, the mainstream transaction prices of P8 fines were around 775 yuan/mt, maintaining stability compared to yesterday's prices. In the Tangshan region, the transaction prices of P8 fines were around 785-790 yuan/mt, also maintaining stability compared to yesterday's prices. Today's industrial data showed a significant improvement MoM, with a substantial rebound in the apparent demand for the five major steel products. Both in-plant inventory and social inventory declined simultaneously. The industrial supply and demand situation is healthy. However, macro sentiment has been fully released, and market sentiment is relatively cautious, with futures and spot prices holding steady. Considering the healthy fundamentals of iron ore itself, high pig iron production, and relatively small overseas supply pressure, it is expected to continue to hold up well in the short term.</div> |  |  |  |  |  |  |

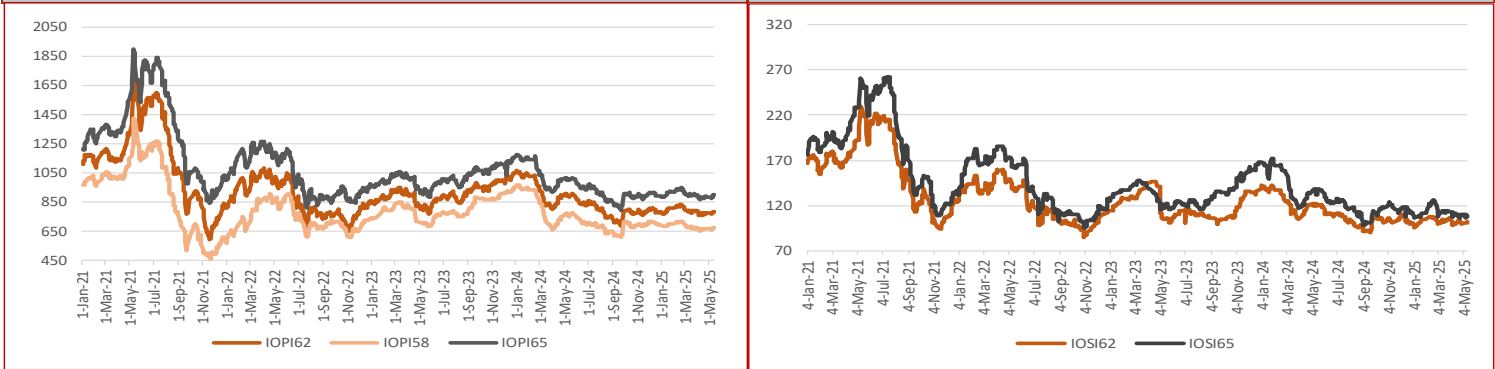

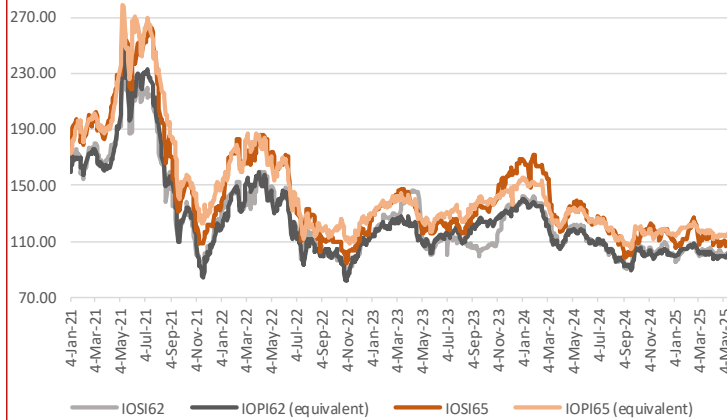

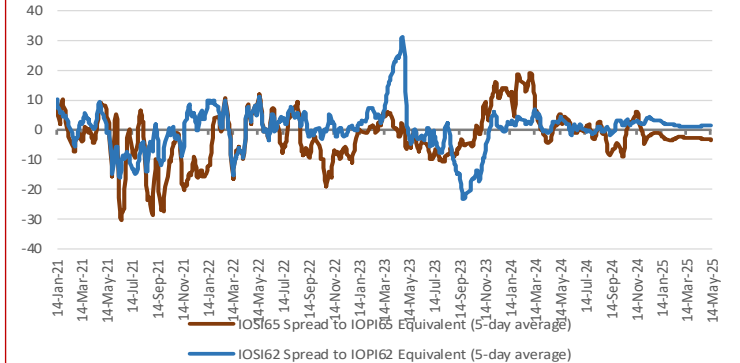
## IRON ORE INDEX PREMIUMS/DISCOUNTS



## WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



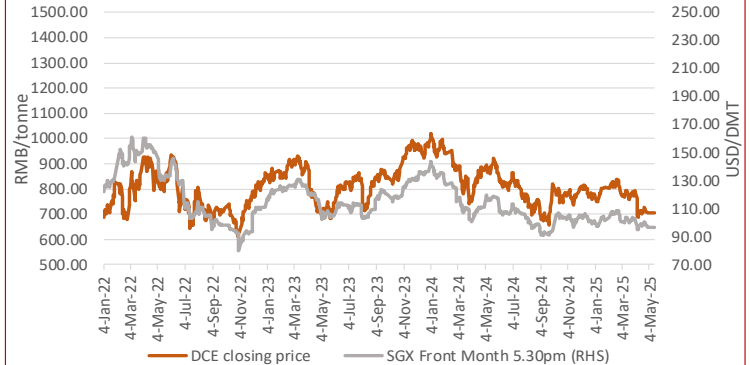
## IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

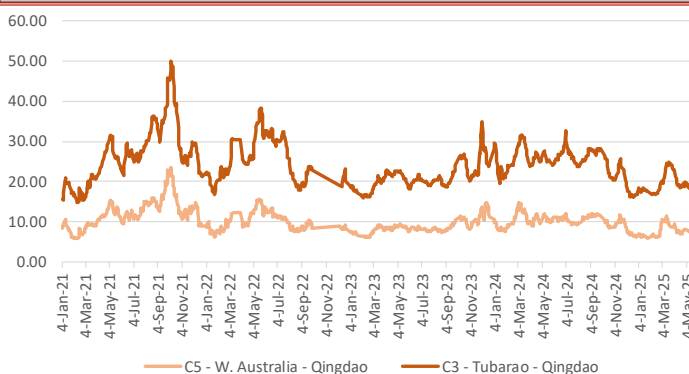

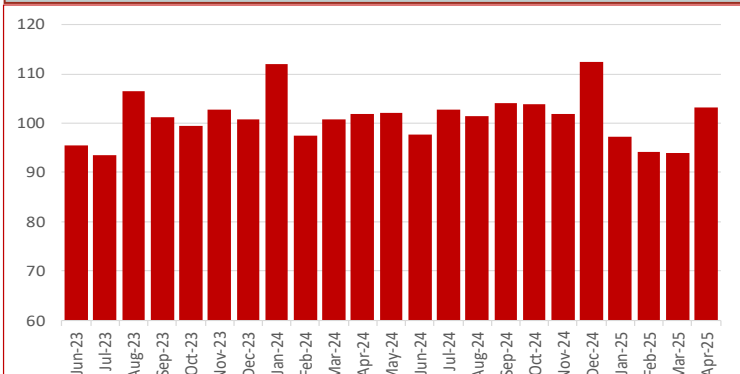

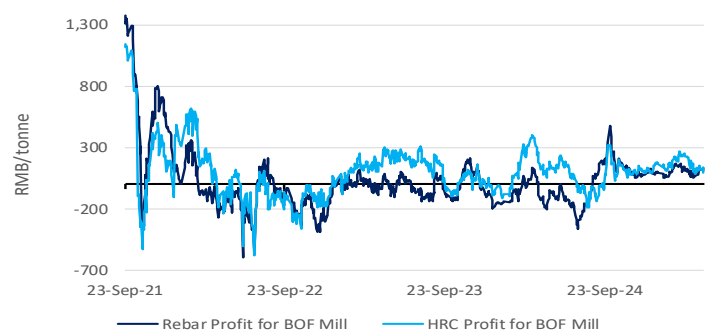

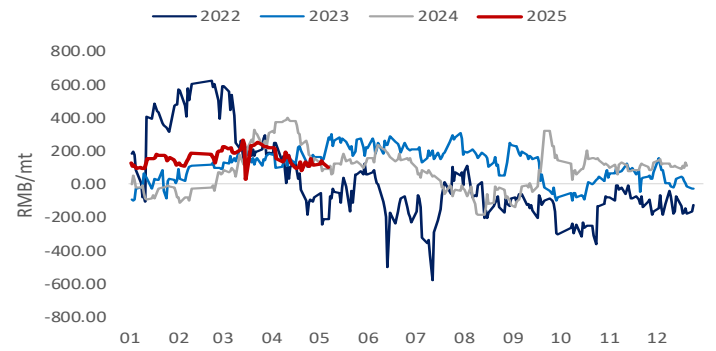

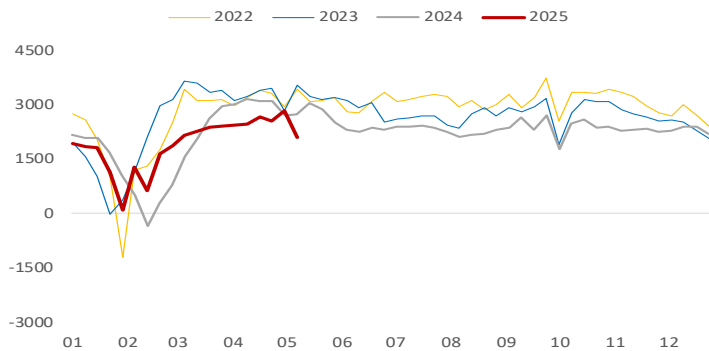
## CHINESE STEEL MILL PROFITABILITY—Rebar



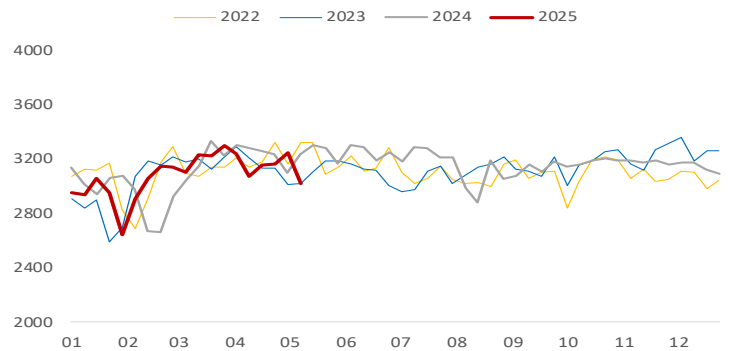
## CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



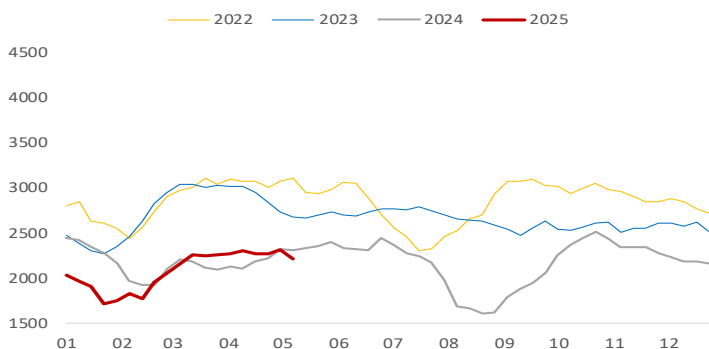
## CHINESE STEEL CONSUMPTION—Rebar



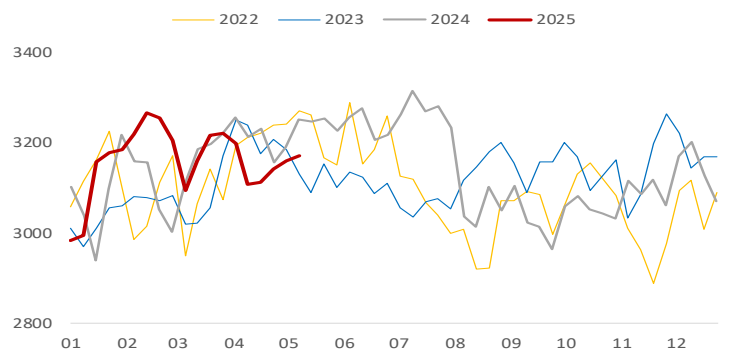

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
