DCE iron ore futures continued to fluctuate in a day, the main contract closed 864.5, an increase of 1.77 throughout the day; Traders ship according to market conditions. Some steel mills tended to be wait-and-see, and purchased on demand, today's overall market transaction atmosphere in general. PBF at Shandong port dealt 850-855 yuan/mt, the same as yesterday. PBF at Tangshan port dealt 860-870 yuan/mt, the same as yesterday.
Based on the demand and inventory data of SMM building materials and hot coil watches today, the demand for watches has slightly decreased and inventory has slightly increased. Belonging to the normal performance of the industry's off-season, it meets market expectations and has a relatively small impact on prices. At present, the market's focus is still on meeting expectations, with strong short-term expectations and inability to verify their authenticity. It is expected that short-term mining prices may continue to fluctuate strongly.

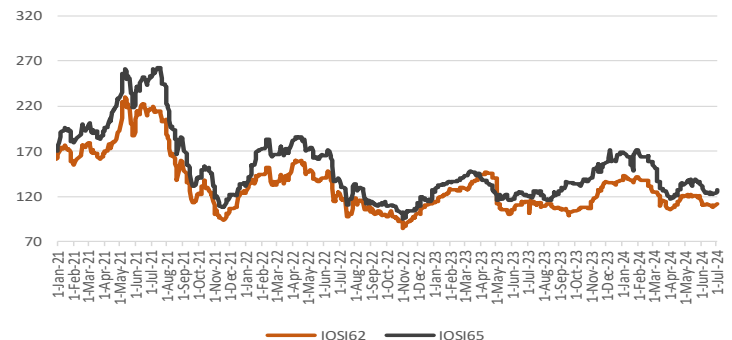

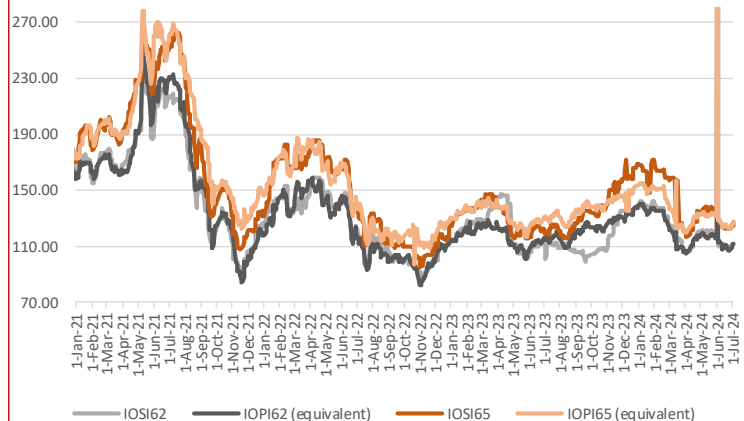

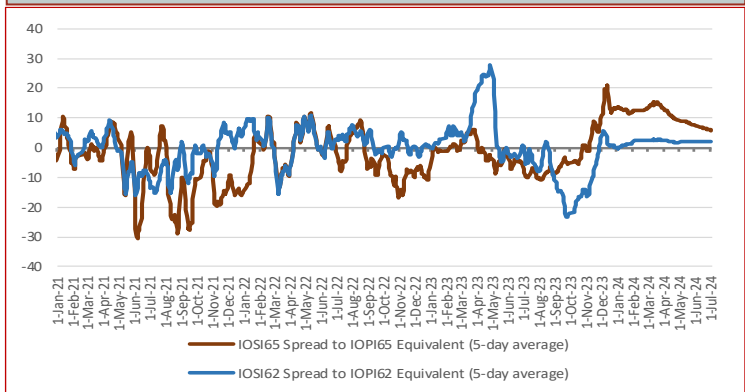

WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



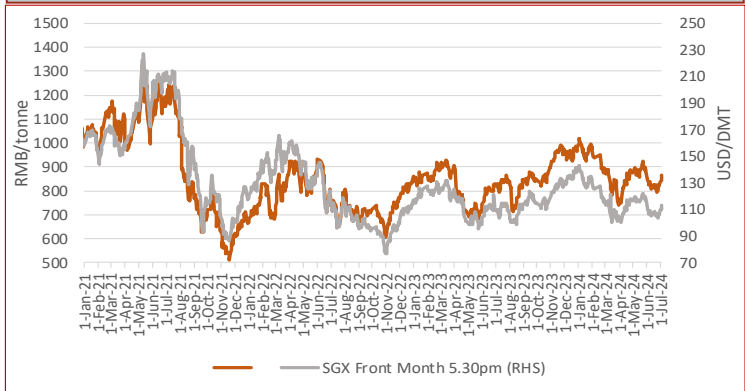
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

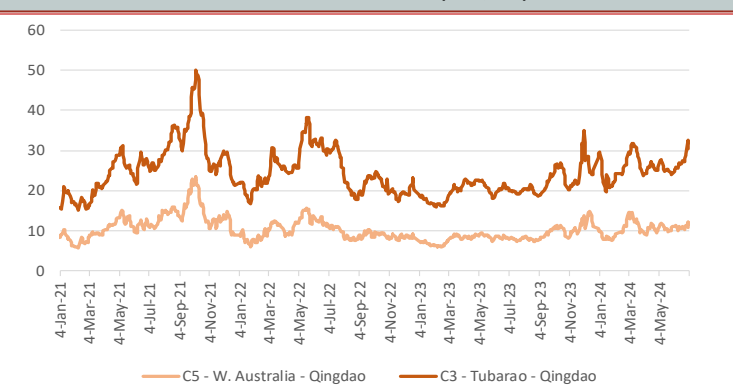

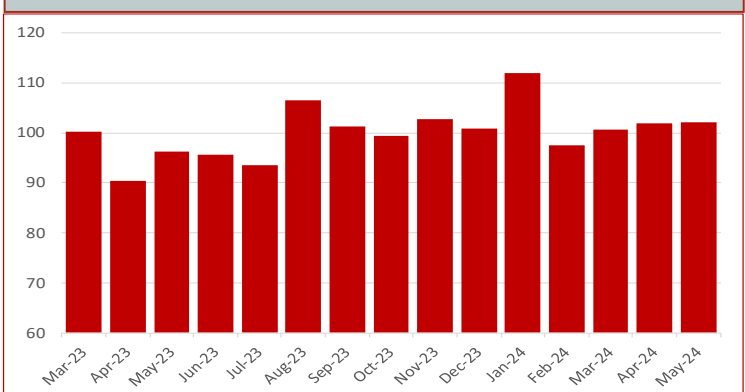

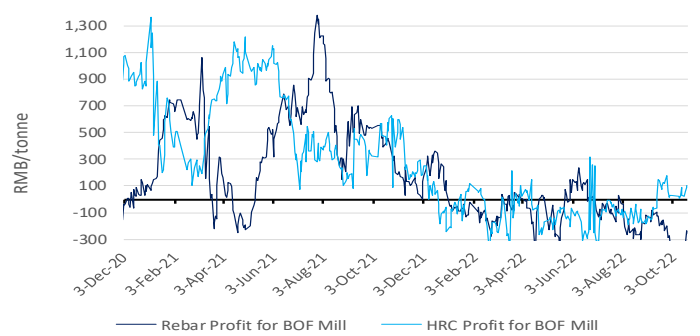

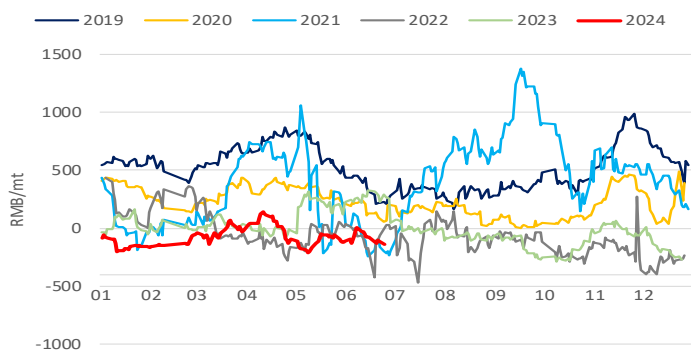

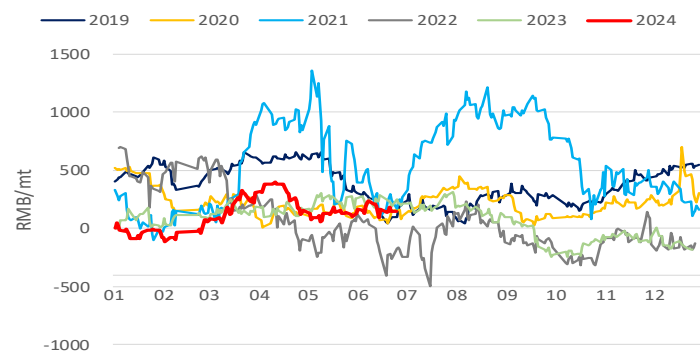
CHINESE STEEL MILL PROFITABILITY



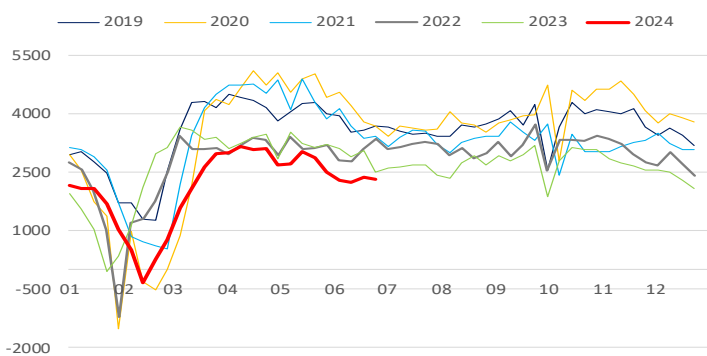
CHINESE STEEL MILL PROFITABILITY—Rebar



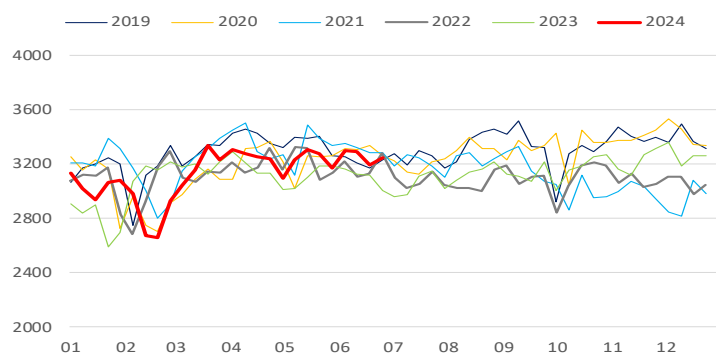
CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



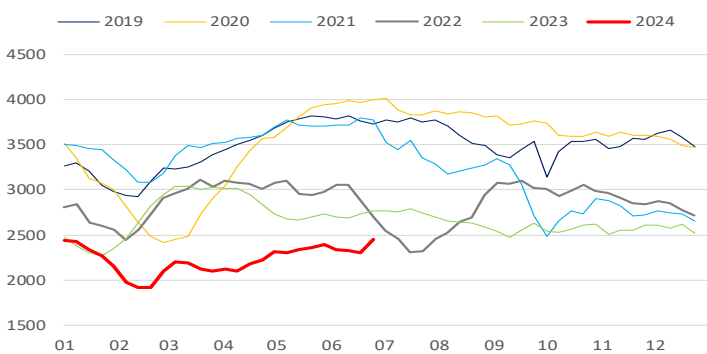
CHINESE STEEL CONSUMPTION—Rebar



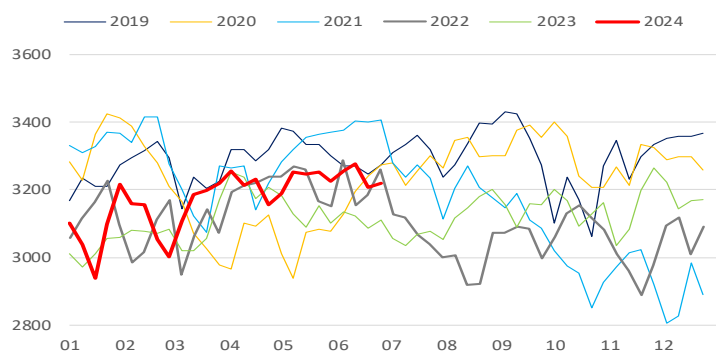

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
