MARKET COMMENTARY

Jun 19th, 2025		CFR Qingdao, USD/dry tonne							Today, DCE iron ore futures continued to drop slightly, but rebounded slightly in the afternoon. The most-traded contract (2509 eventually closed at 698, up 0.43% for the day. Traders sold goods according to market conditions, with limited speculative transactions. Steel mills adopted a wait-and-see attitude cautiously, with a strong desire to bargain down prices. The market transaction atmosphere was average. In the Shandong region, the mainstream transaction prices of PB fines were around 710 yuan/mt, up 2-3 yuan/mt from yesterday's prices. In the Tangshan region, the transaction prices of PB fines were around 720 yuan/mt, basically stable compared to yesterday's prices. From today's industrial data, the apparent consumption of the five major steel products showed an overall improvement, with a significant MoM increase in plate and coil demand. Rebar only dropped back slightly under the influence of heavy rain and the senior high school entrance examination. It is worth noting that against the backdrop of increasing total production, steel inventory still maintained a de-stocking trend.

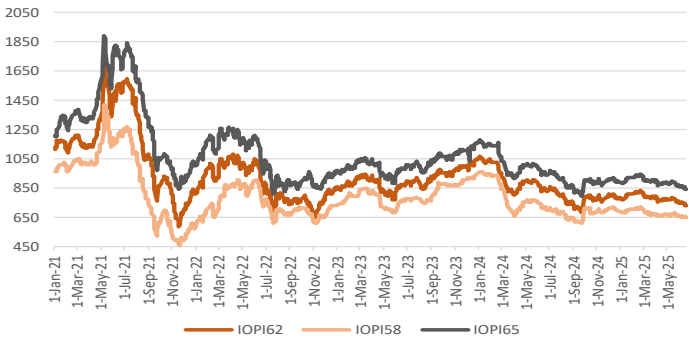

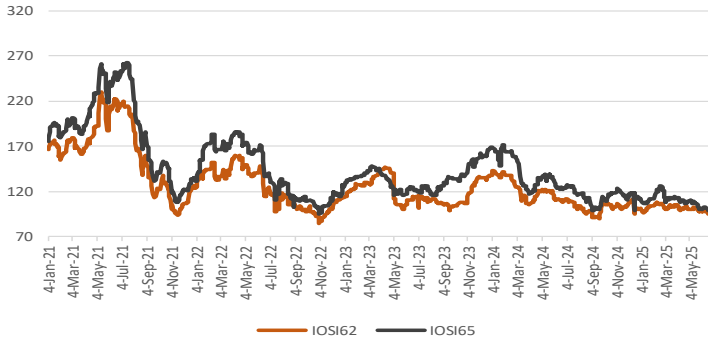

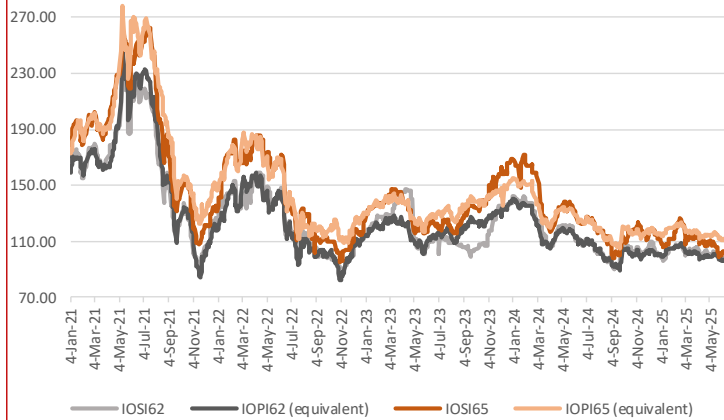

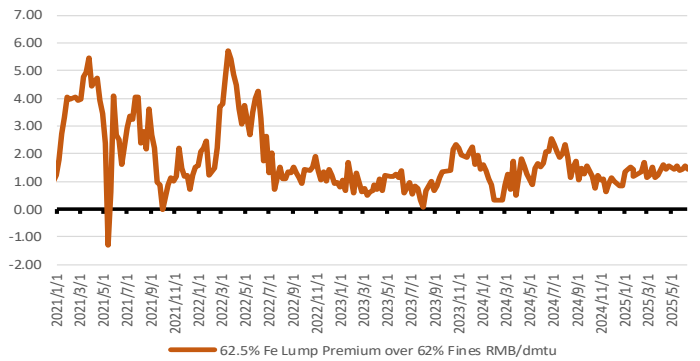

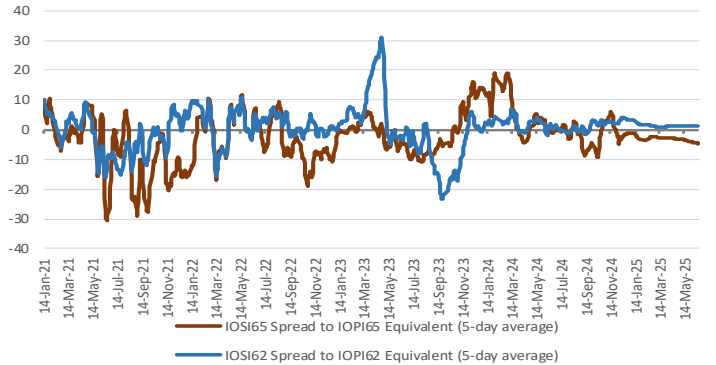

WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



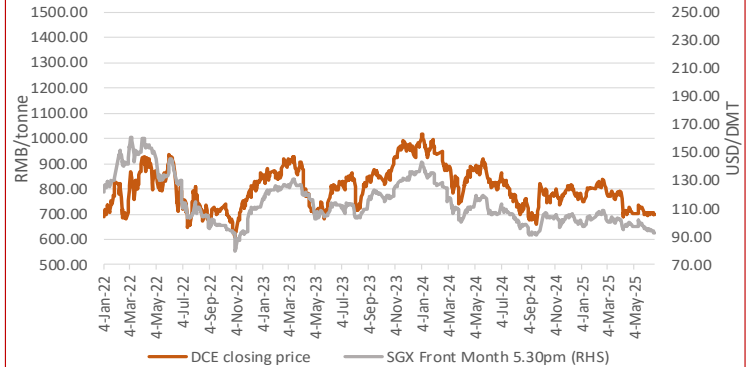
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

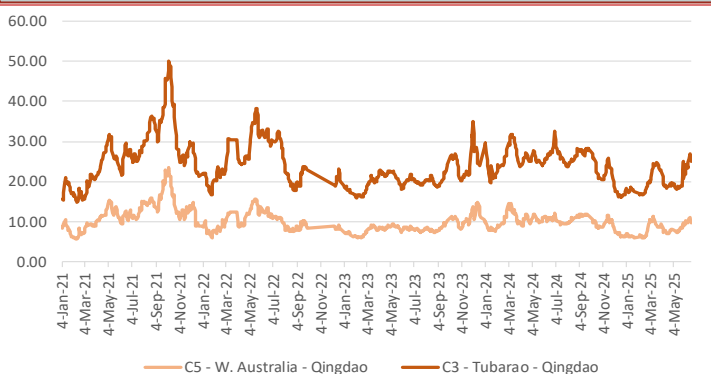

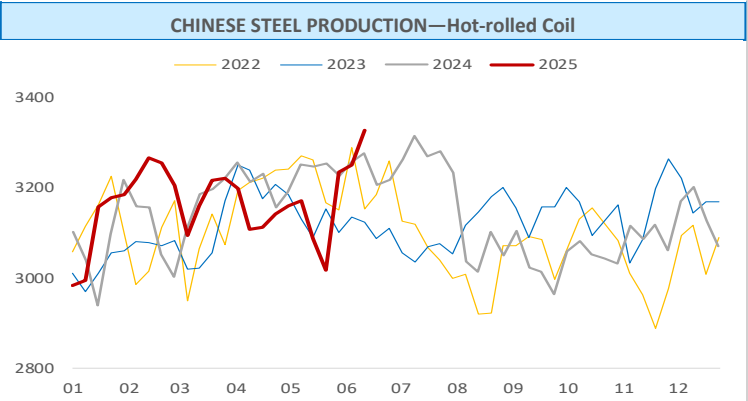
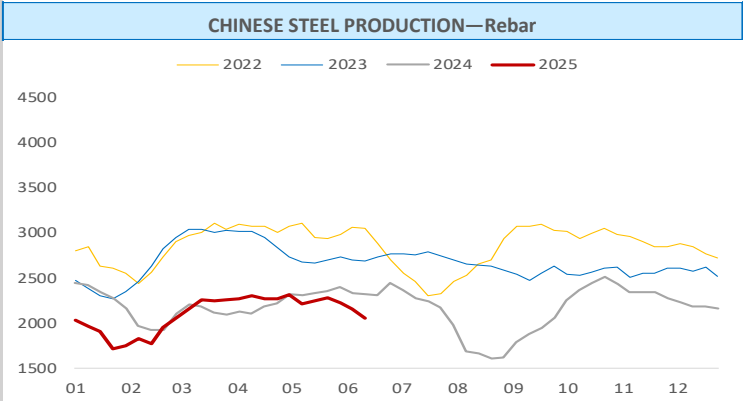
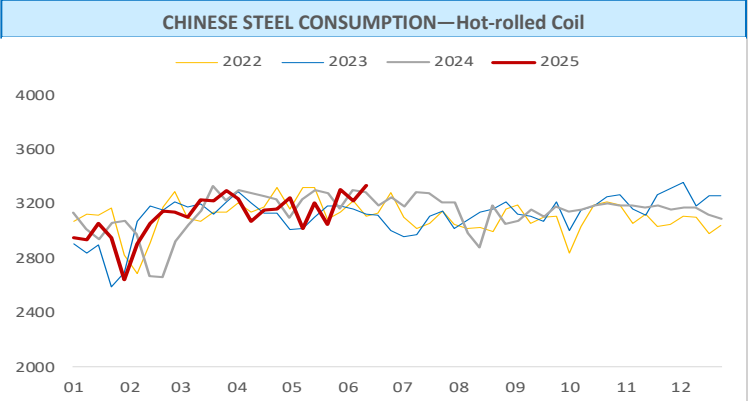
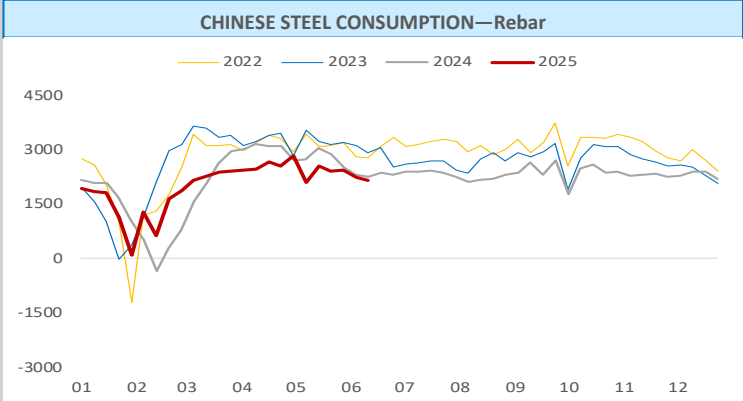
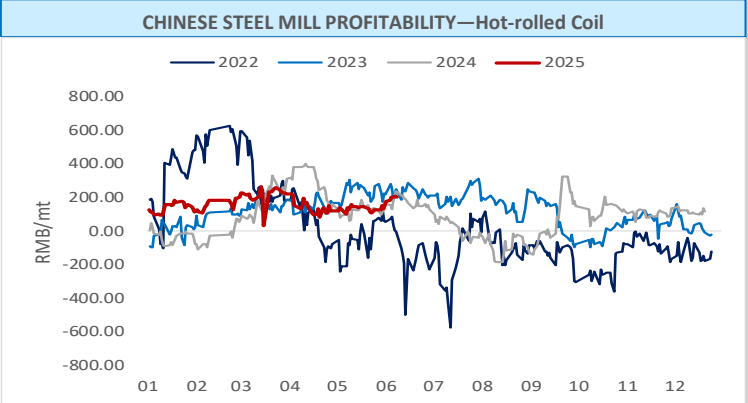
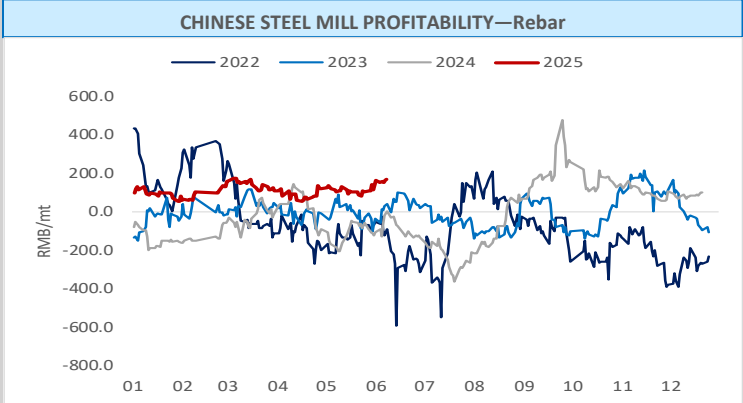
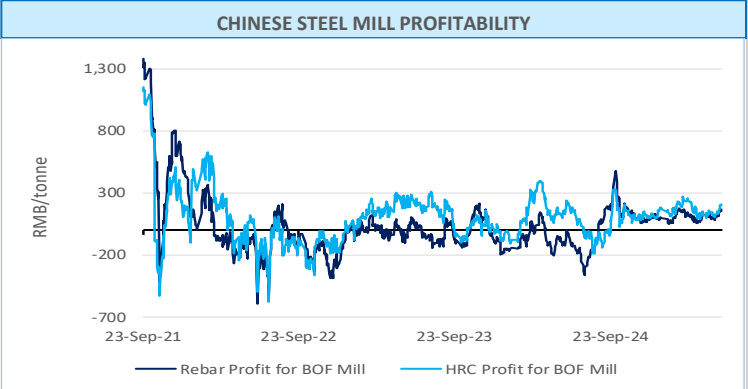
TOTAL CHINA IRON ORE IMPORT VOLUMES (MILLION TONNES)

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
