MARKET COMMENTARY

Oct 30th, 2023		CFR Qingdao, USD/dry tonne							DCE iron ore futures continued to rise in a day by 2.51%, the main contract i2401 closed 900. some traders were active to sell. Some steel mills tended to be wait-and-see, and purchased on demand. today's overall market transaction atmosphere in general. PBF at Shandong port dealt 950-952 yuan/mt; increased 5-7 yuan/mt from last Friday. PBF at Tangshan port dealt 867-870 yuan/mt; increased 7-10 yuan/mt from last Friday. According to SMM shipping data, global shipping volume fell 11.7% month on month last week to 28.04 million tons. Among them, Australia experienced a significant decline of 27.9% month on month. And with the recent decline in the proportion of Australia and Brazil shipping to China, coupled with some ports experiencing a decline in unloading efficiency due to the impact of uplift, the port volume decreased by 32.84% month on month this week to 18.542 million tons. Low arrival volume may lead to a decline in port inventory. Despite an increase in the number of steel mills undergoing maintenance, the production of molten iron is still at a high level, and the fundamentals still have strong support for ore prices. Combined with recent macroeconomic policies, mining prices have continued to rise. Considering regulatory risks and deepening losses in steel mills or increasing blast furnace maintenance, there is little room for upward pressure on ore prices due to the suppression of ore prices. Short term ore prices may fluctuate at high levels.

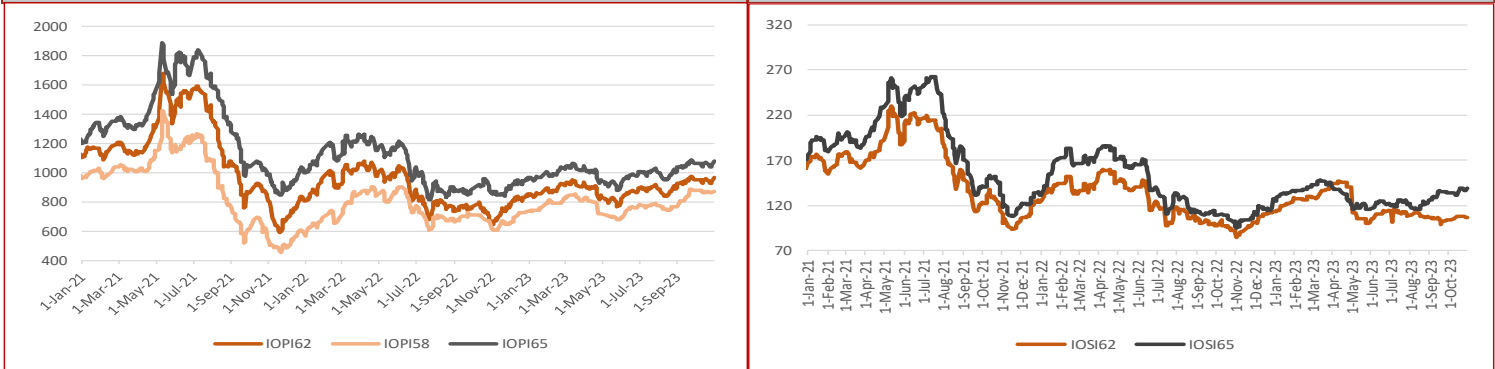

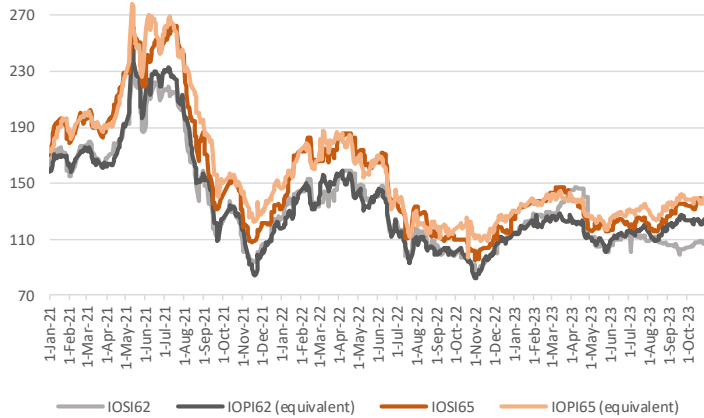

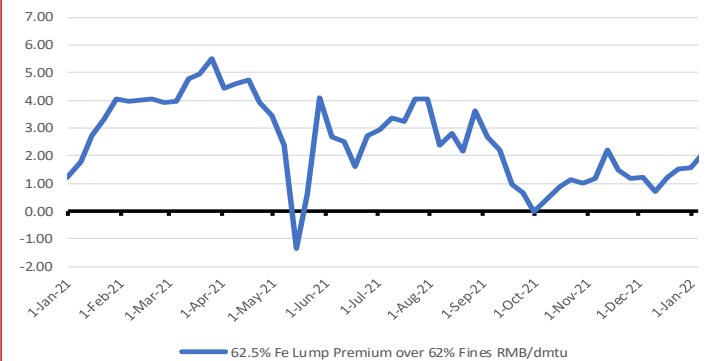

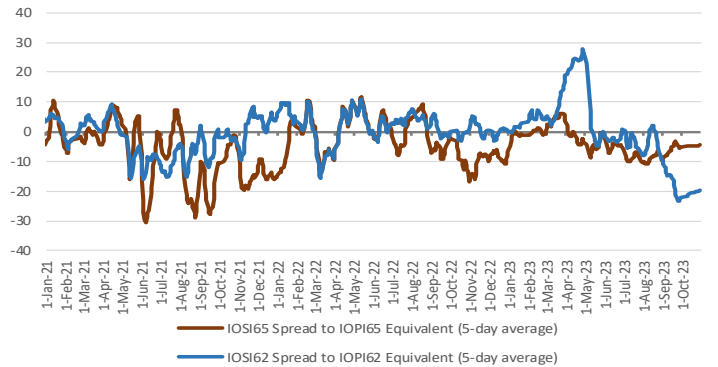

WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



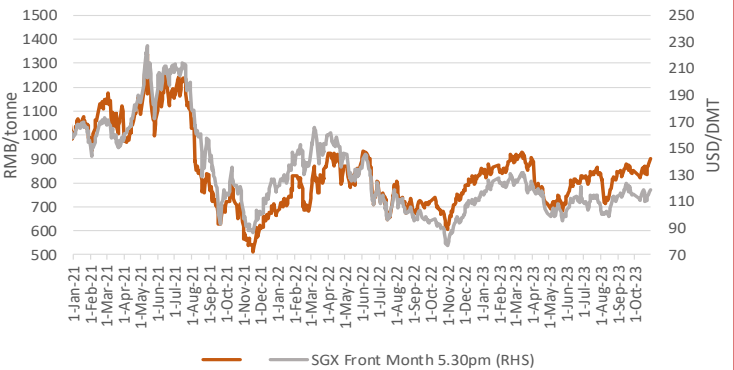
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

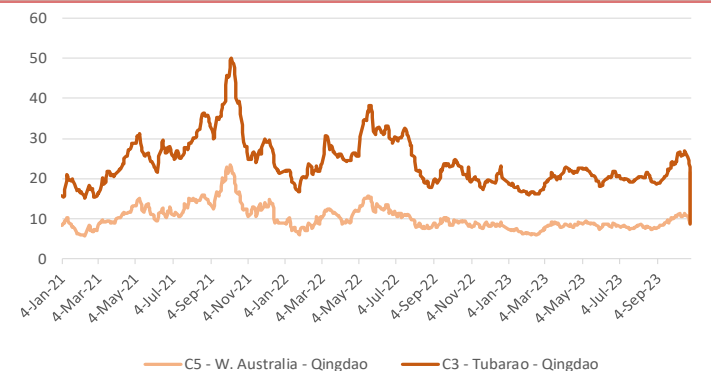

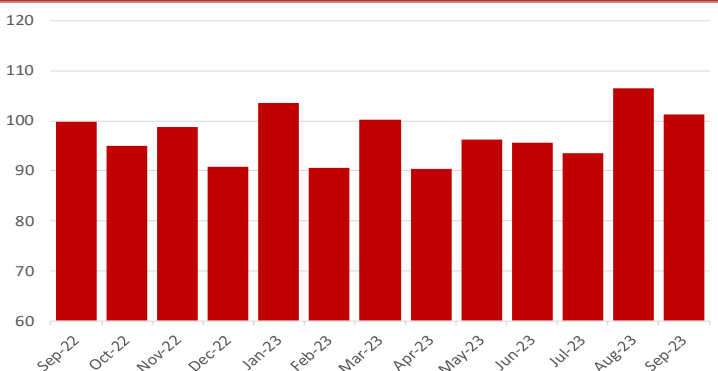

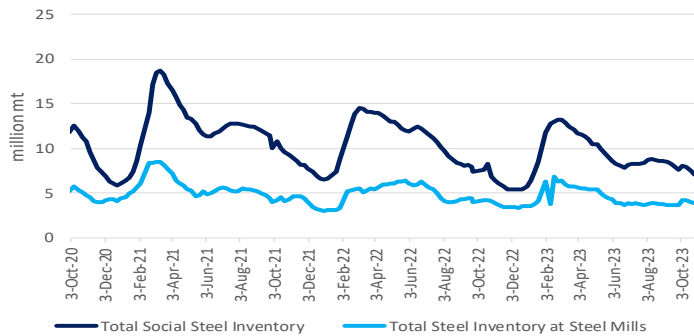

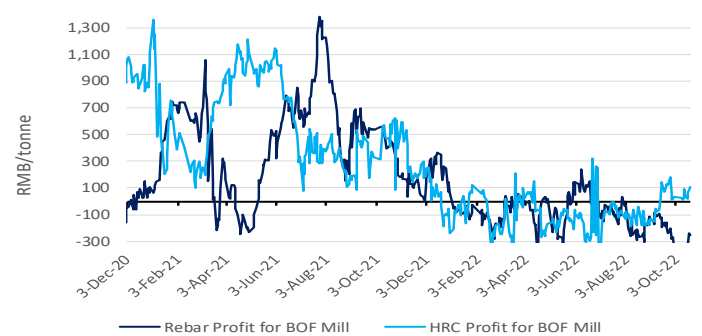

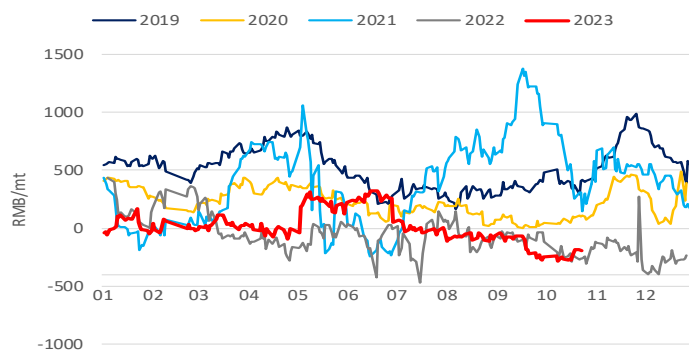

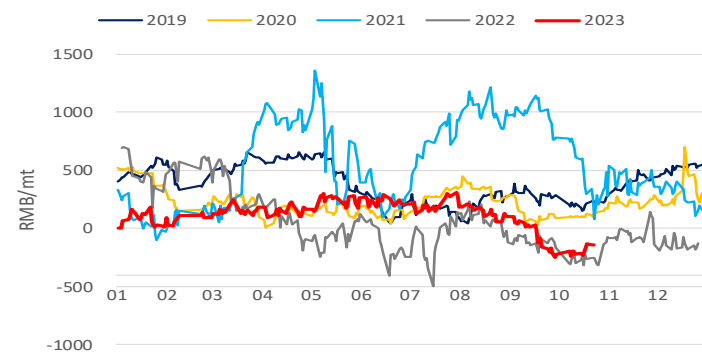
CHINESE STEEL MILL PROFITABILITY



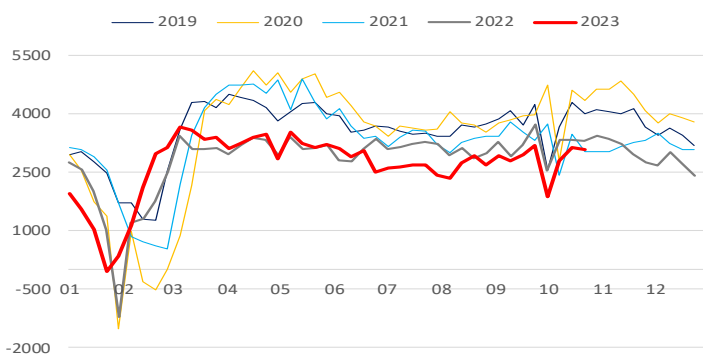
CHINESE STEEL MILL PROFITABILITY—Rebar



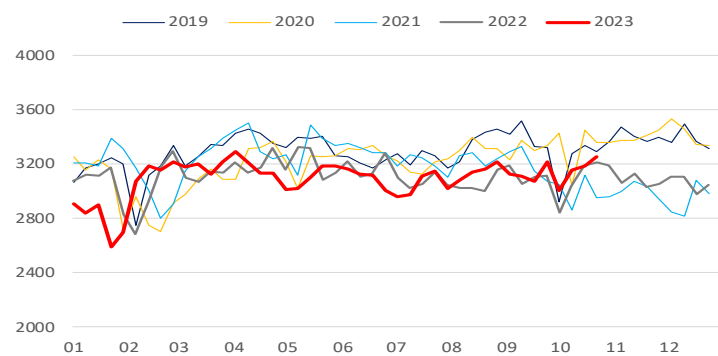
CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



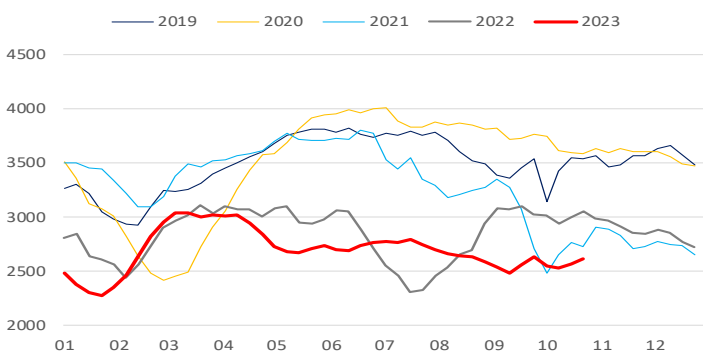
CHINESE STEEL CONSUMPTION—Rebar



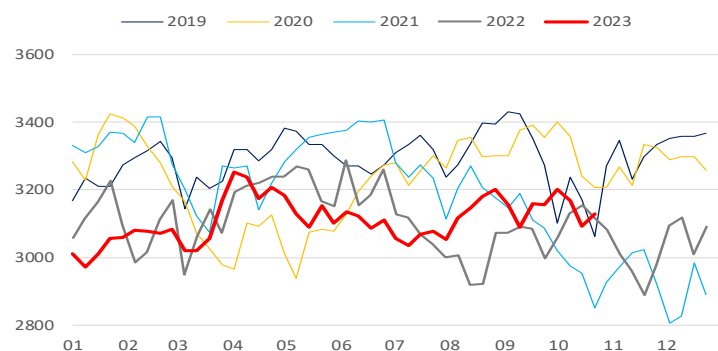
CHINESE STEEL CONSUMPTION—Hot-rolled Coil

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
