MARKET COMMENTARY

Aug 16th, 2024		CFR Qingdao, USD/dry tonne							Today, iron ore prices fluctuated, with the main contract 12501 experiencing a high and then a low, closing at 697, down 0.99% for the day. Some traders were unable to deliver on their contracts, indicating poor purchasing intentions from steel mills. The overall market atmosphere was quiet today, with limited trading activities. In Shandong, the price of PB powder ranged from 700-705 yuan/ton, a decrease of 5-10 yuan/ton from yesterday; while in Tangshan, the price ranged from 712-720 yuan/ton, a decrease of 5-10 yuan/ton from yesterday. As of August 16th, SMM tracked 35 port inventories totaling 147.16 million tons, an increase of 490,000 tons compared to the previous period and an increase of 29.83 million tons compared to the same period last year. The daily average import volume of ore is 3.086 million tons, an increase of 120,000 tons compared to the previous period, but a decrease of 88,000 tons compared to the same period last year. This week, iron ore prices hit a new low, prompting steel mills to replenish their stocks at low levels, leading to an increase in spot transaction volumes and port throughput. This indicates that there is still demand support for iron ore. Considering the lack of substantial improvement in end demand, it is expected that ore prices will continue to fluctuate at low levels.

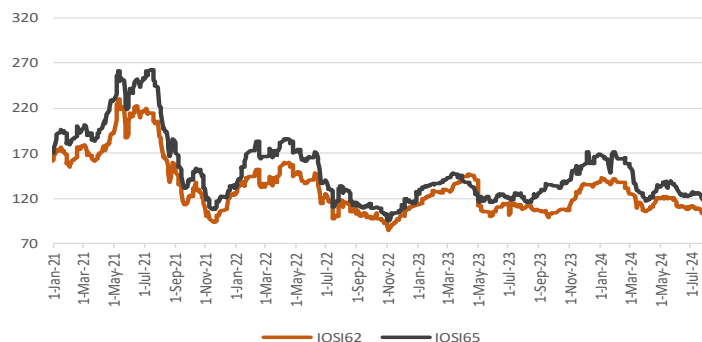

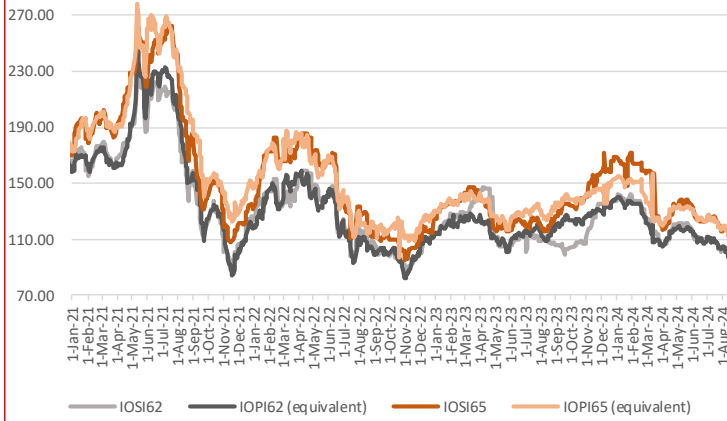

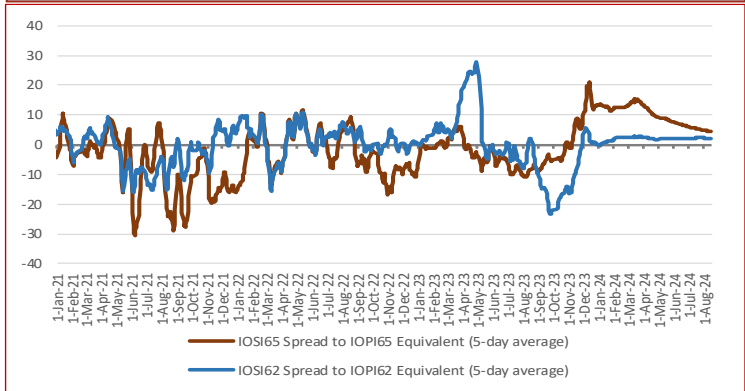

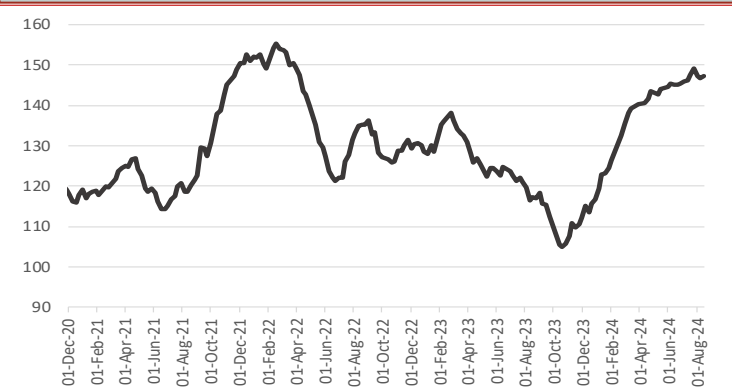
WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



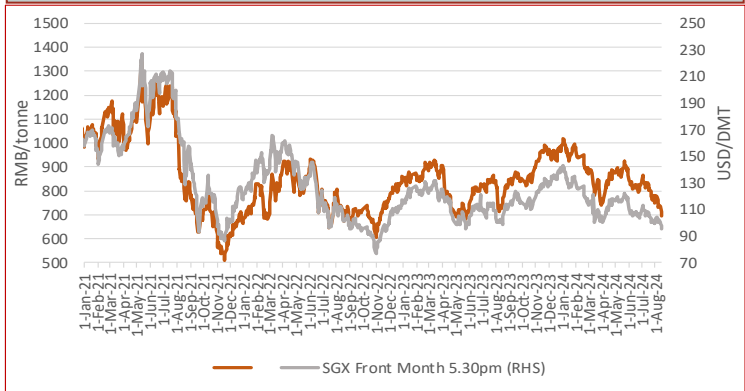
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

FUTURE TRADING—FRONT MONTH CLOSING PRICE



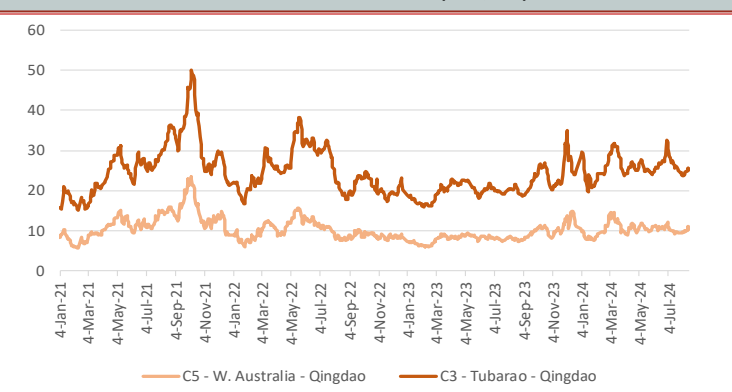

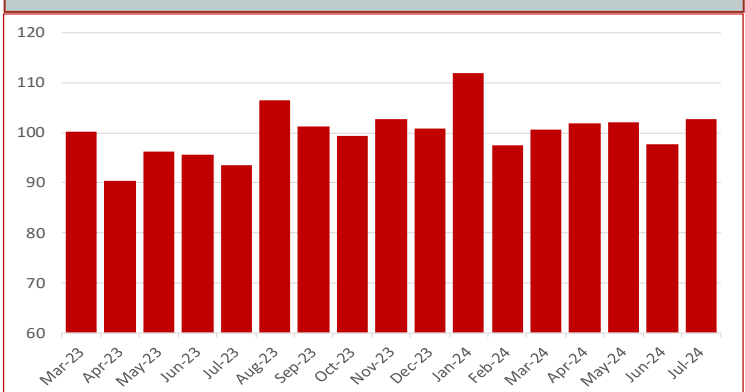

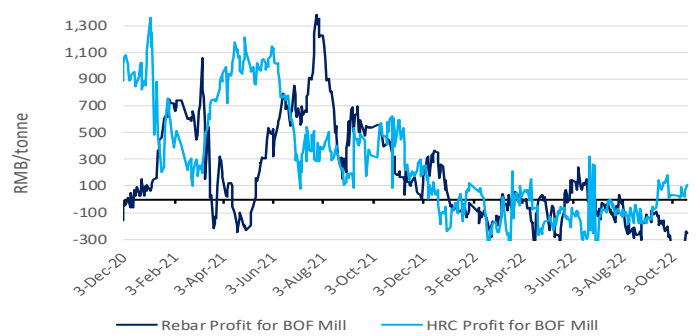

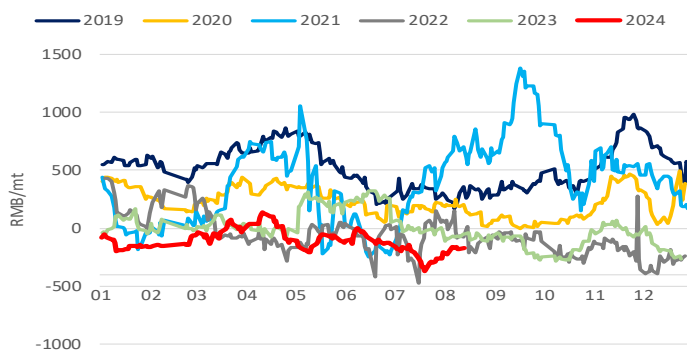

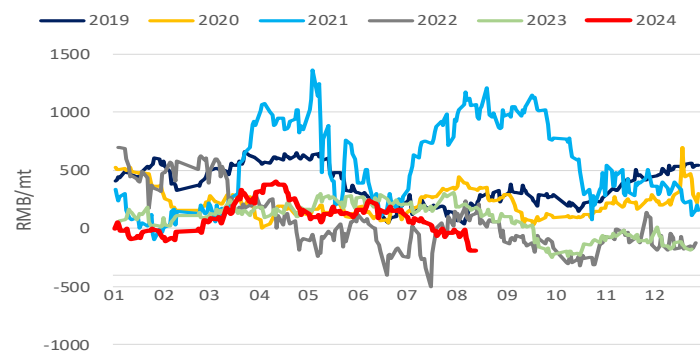
CHINESE STEEL MILL PROFITABILITY



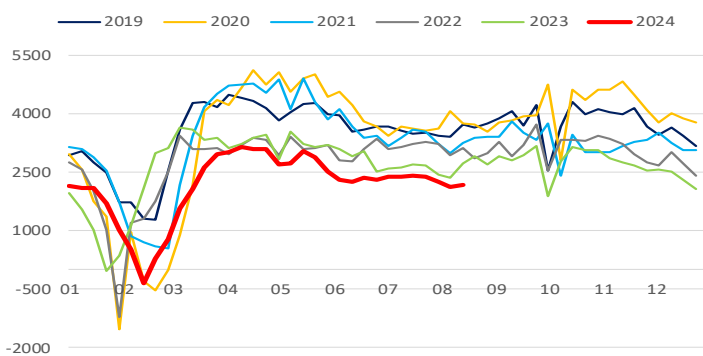
CHINESE STEEL MILL PROFITABILITY—Rebar



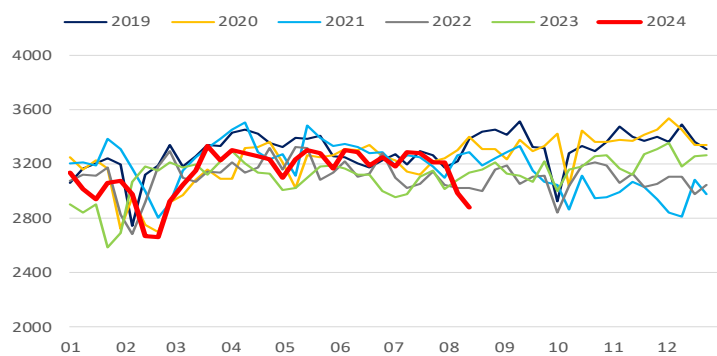
CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



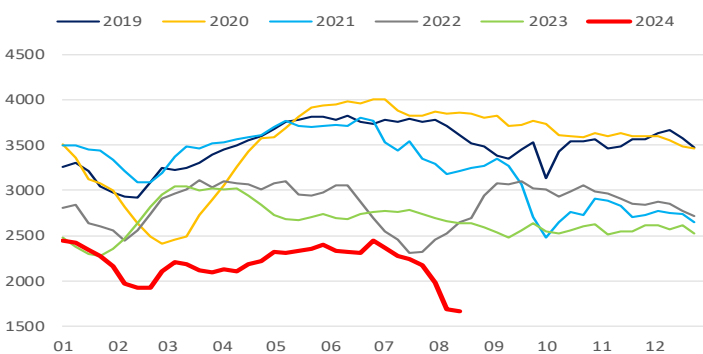
CHINESE STEEL CONSUMPTION—Rebar



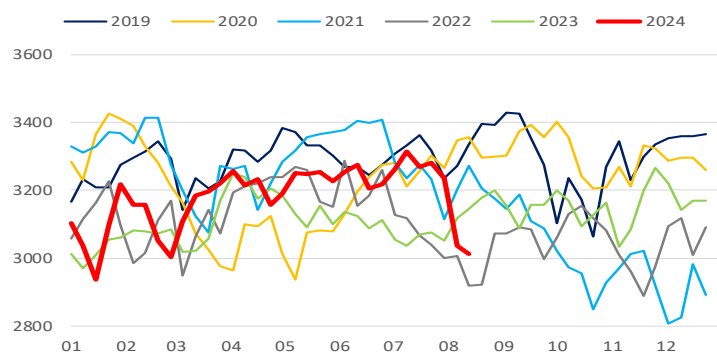
CHINESE STEEL CONSUMPTION—Hot-rolled Coil

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
