MARKET COMMENTARY

May 8th, 2025		CFR Qingdao, USD/dry tonne							Today, DCE Iron Ore futures saw a significant decline, with the most-traded contract I2509 closing at 693.5, down 2.73% for the day. Traders' enthusiasm for selling was moderate; steel mills purchased as needed, and the market transaction atmosphere was acceptable. The main-stream transaction prices of P8 fines in the Shandong region were around 750-755 yuan/mt, down 5-10 yuan/mt from yesterday's prices; the transaction prices of P8 fines in the Tangshan region were around 765-770 yuan/mt, also down 5-10 yuan/mt from yesterday's prices. Today iron ore futures prices fell sharply, mainly due to the combined impact of three bearish factors: firstly, the detailed rules of the crude steel production reduction policy were further clarified; secondly, the apparent demand for the five major steel products dropped sharply on a WoW basis, triggering market concerns about "negative feedback"; thirdly, the Trump administration sent a tough signal in tariff negotiations with China. However, with pig iron production currently at a high level, the overall demand for iron ore remains good, providing some support

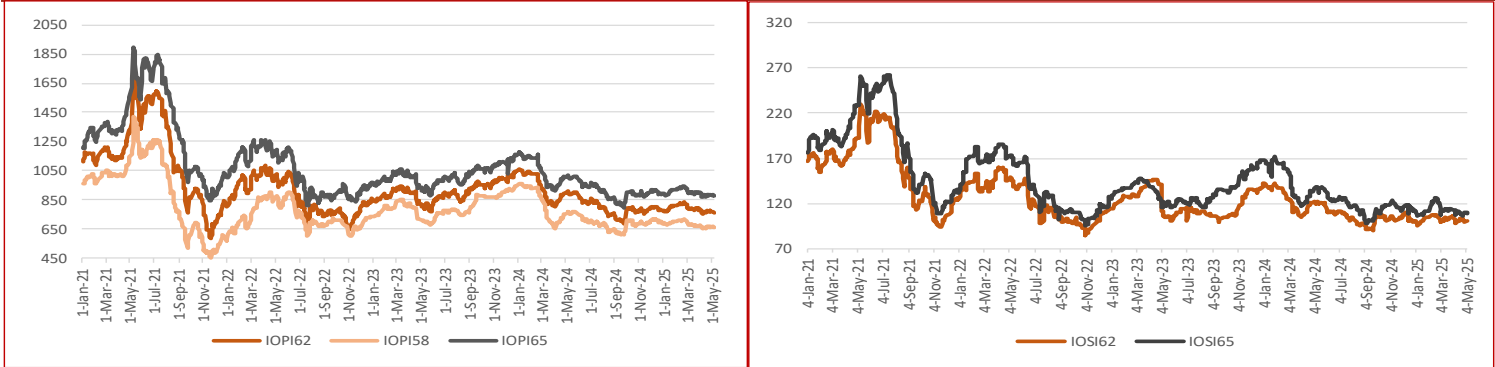

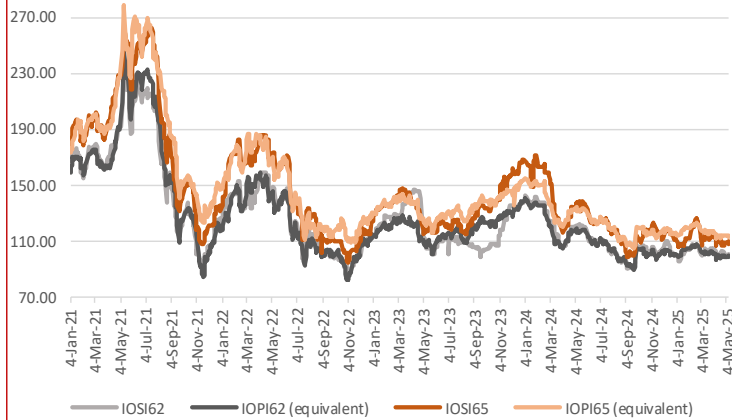

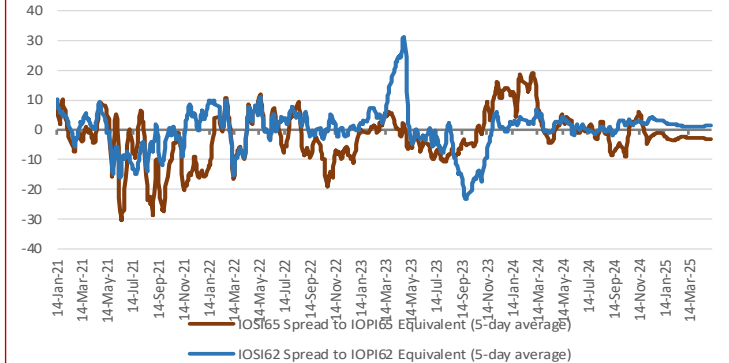

WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



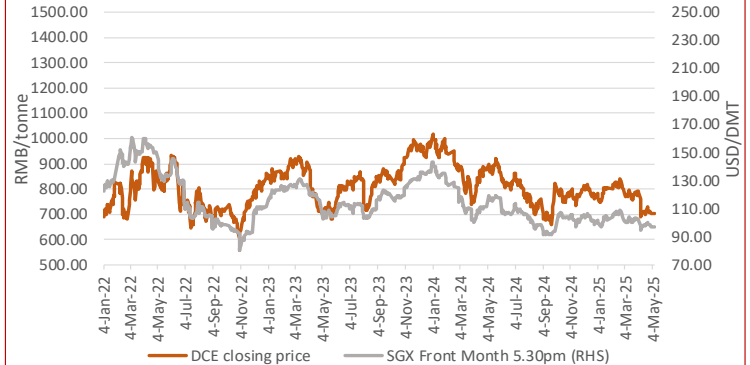
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

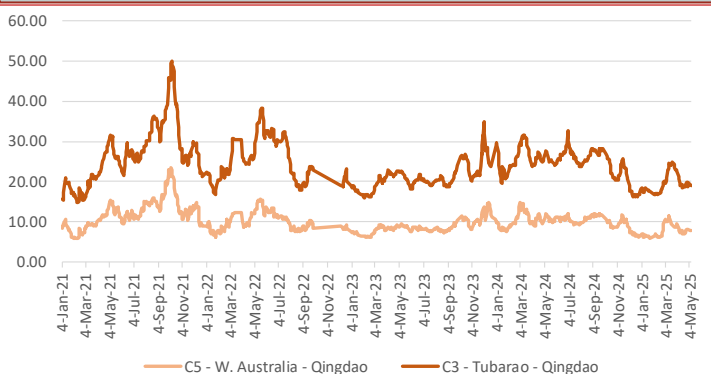

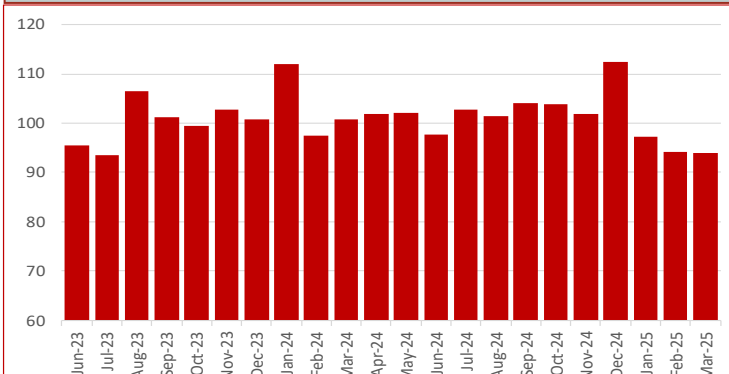

DRY BULK FREIGHT RATES (USD/MT)



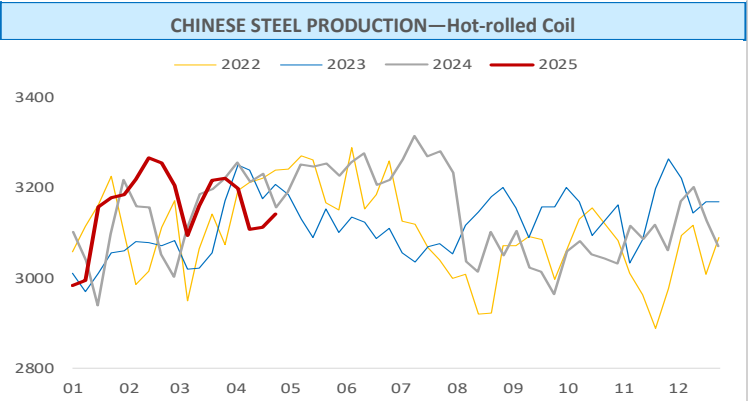
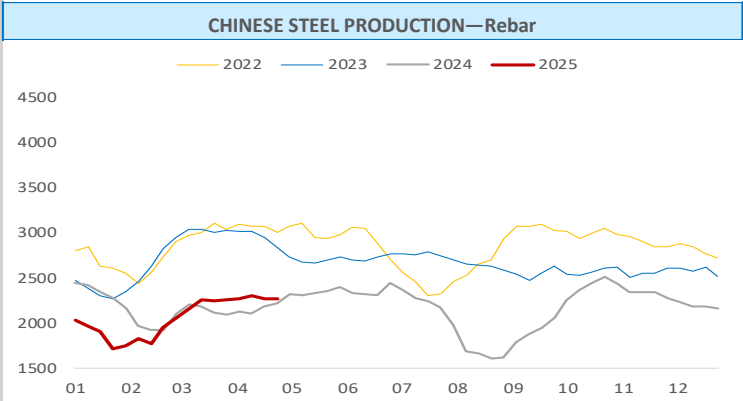
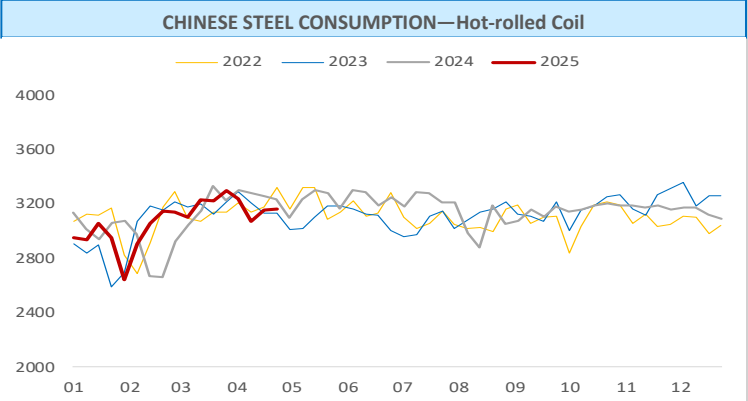
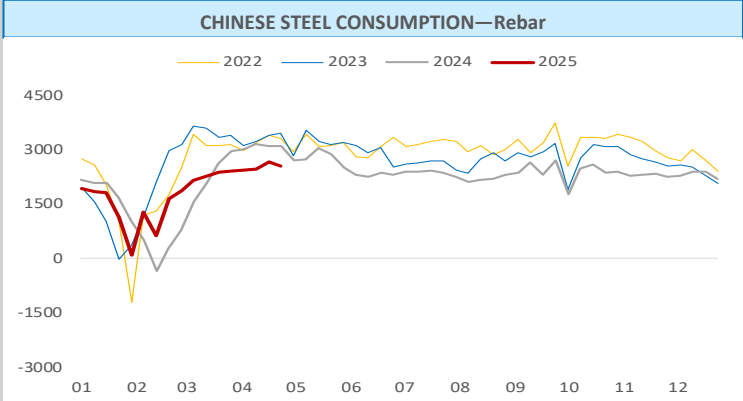
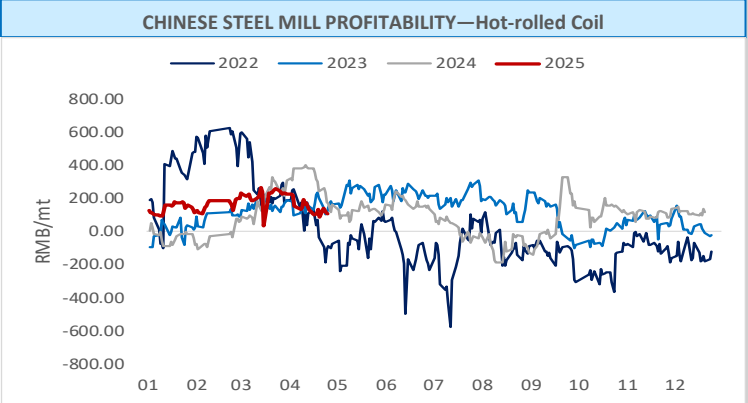
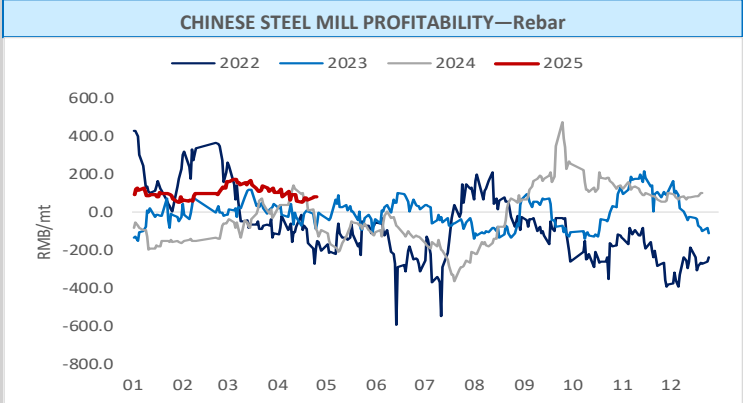
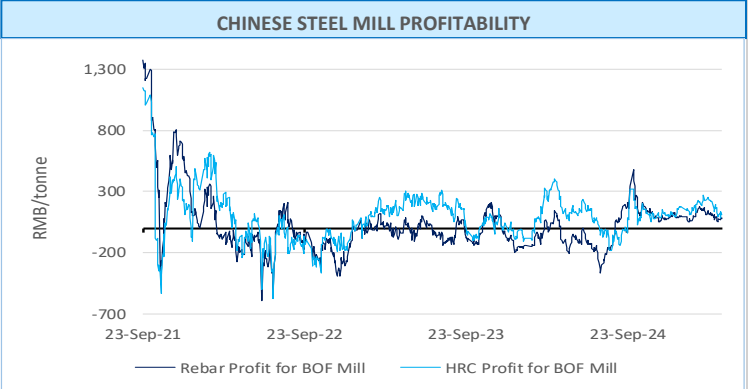

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
