## MARKET COMMENTARY

Dec 25th, 2024		CFR Qingdao, USD/dry tonne							Today, DCE iron ore futures fluctuated repeatedly. The most-traded contract (2505) finally closed at 776 yuan/mt, remaining stable compared to yesterday. Traders showed moderate willingness to sell. Steel mills purchased as needed, with inquiries increasing compared to the previous two days. Market transactions were average today. In Shandong, mainstream transaction prices for PB fines were around 770 yuan/mt, down by 5-10 yuan/mt from yesterday; in Tangshan, transaction prices for PB fines were 785 yuan/mt, down by 0.5 yuan/mt from yesterday. On December 25, SMM reported that the blast furnace operating rate of 242 steel mills was 85.37%, down 0.1 percentage points WoW. The blast furnace capacity utilisation rate was 86.91%, also down 0.1 percentage points WoW. The daily pig iron production of sample steel mills averaged 2.3446 million mt, down 3,000 mt WoW. Moreover, several blast furnaces have announced maintenance plans for January, and pig iron production is expected to see slight downside room. Iron ore demand continued to weaken. Additionally, there was no positive macro news in the short term, and ore prices are unlikely to see a sustained rebound this week, likely continuing to fluctuate downward.












CHINESE STEEL MILL PROFITABILITY




CHINESE STEEL MILL PROFITABILITY—Rebar




CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil







## IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
