MARKET COMMENTARY

Oct 10th, 2023		CFR Qingdao, USD/dry tonne							DCE iron ore futures declined by 1.74 % today, the main contract closed at 819. The steel mills are active to purchase. The overall trading sentiment of the market is general. PBF at Shandong port deal 909-910 yuan/mt. On the surface of the news, there has been another thunderstorm news from the real estate sector, causing market discussions and generating a certain level of pessimism. Based on the maintenance data of steel mills' blast furnaces tracked by SMM, the impact of blast furnace maintenance this week was 923700 tons, an increase of 57600 tons compared to last week's maintenance. It is expected that the daily average iron production of blast furnaces will slightly decrease this week. Last week, the inventory of Port 35 still slightly decreased, but some ports in South China have been affected by typhoons recently, which may affect the arrival of iron ore. It is expected that there will be no significant accumulation of iron ore in the port this week. It is expected that the short-term iron ore prices will continue to fluctuate widely.

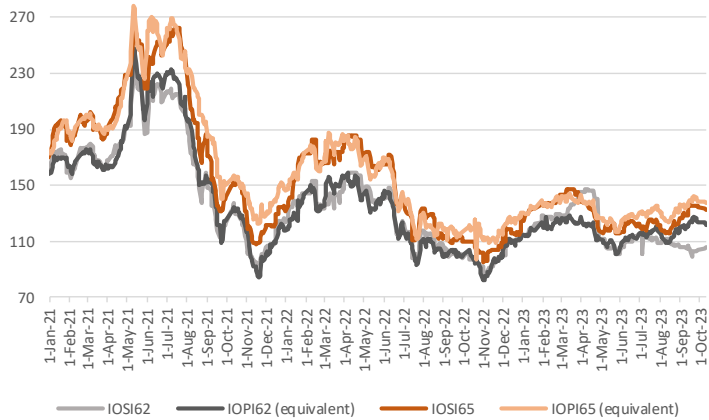

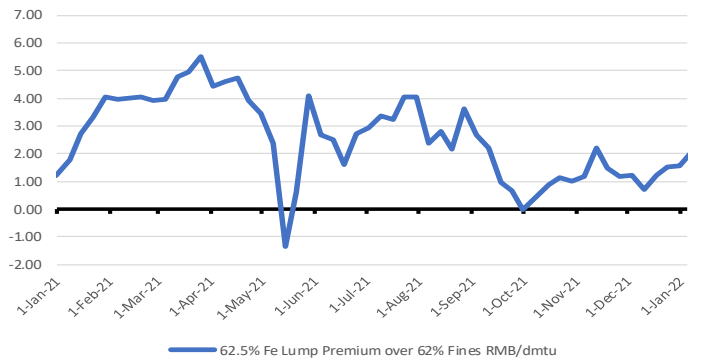

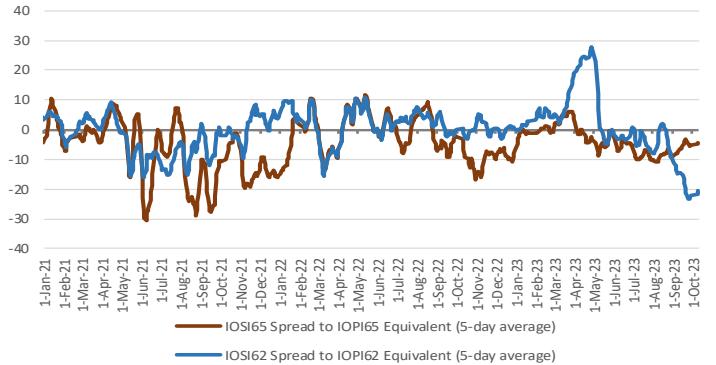

WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



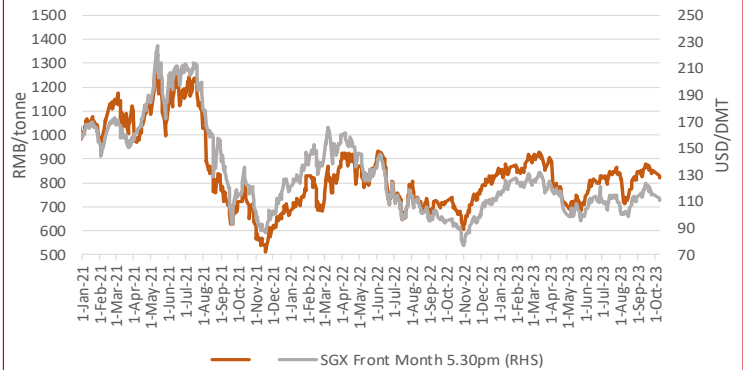
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

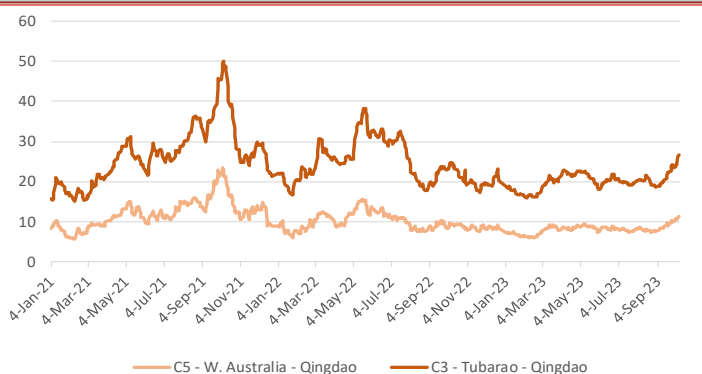

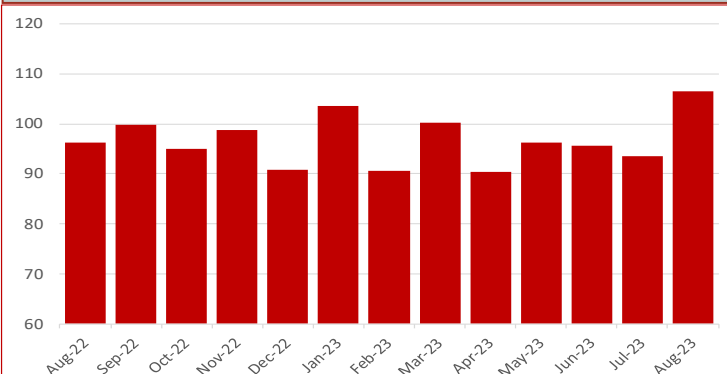

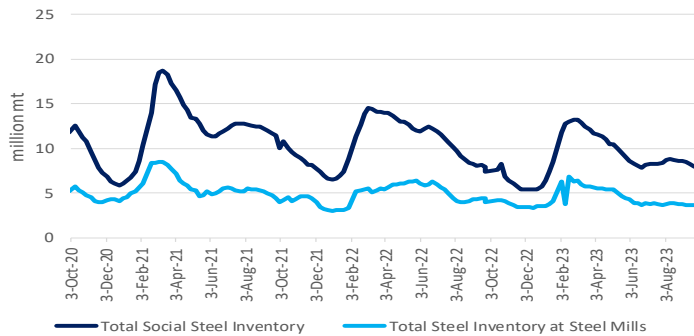

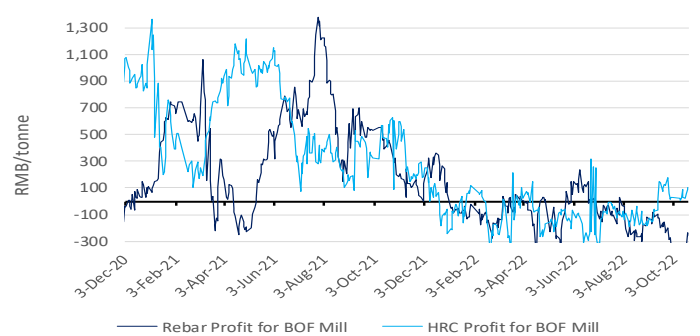

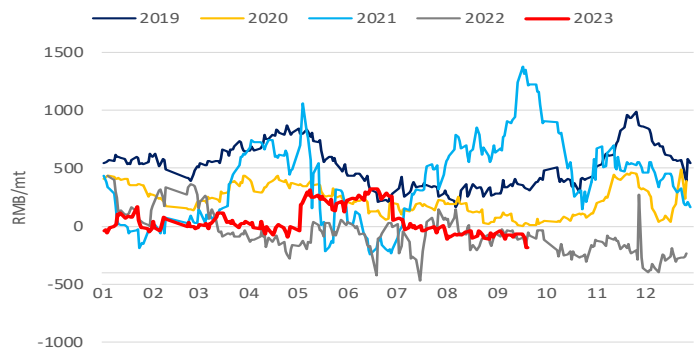

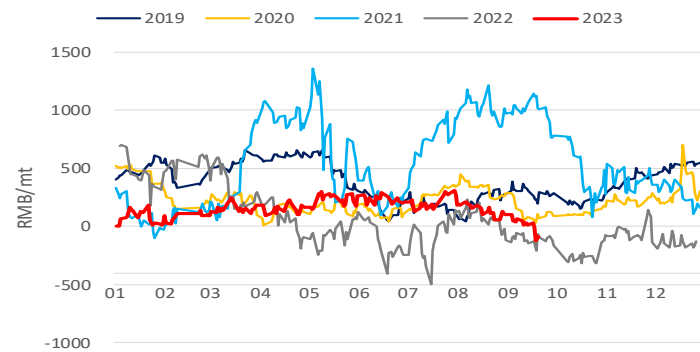
CHINESE STEEL MILL PROFITABILITY



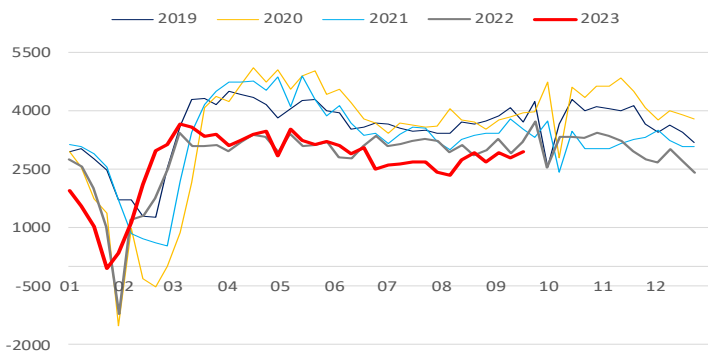
CHINESE STEEL MILL PROFITABILITY—Rebar



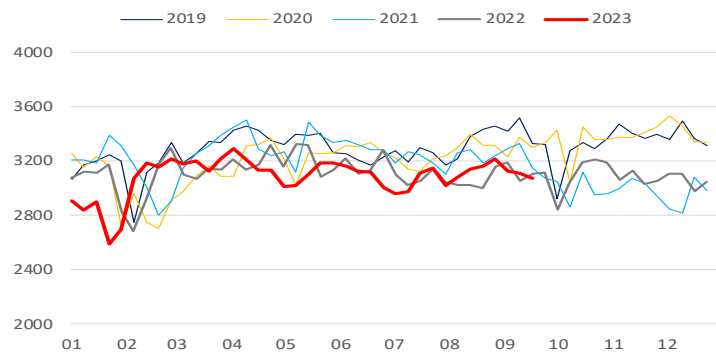
CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



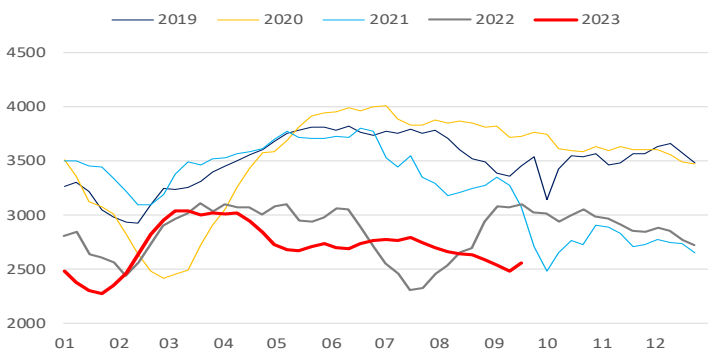
CHINESE STEEL CONSUMPTION—Rebar



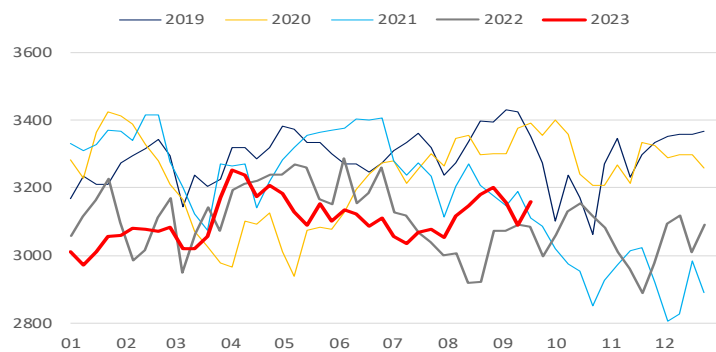

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
