DCE iron ore futures tight by 0.48% in the day, the main contract closed 834, an increase of 3.34% throughout the day. Traders have average enthusiasm for shipping and tend to ship according to market trends. Some steel mills purchase on demand. The overall market transaction atmosphere today is average, today's overall market transaction atmosphere in general. PBF at Shandong port deal: 825-835 yuan/mt, increased 5 yuan/mt over yesterday. PBF at Tangshan port deal: 845-850 yuan/mt, increased 5-10 yuan/mt over yesterday. According to SMM statistics, this week (July 6th to July 12th), the impact of blast furnace maintenance on molten iron was 978200 tons, an increase of 37500 tons compared to last week's maintenance. The impact of blast furnace maintenance on molten iron next week (July 13th to July 19th) is 1.0398 million tons, an increase of 61600 tons compared to this week. The production of molten iron has slightly declined, but the proportion is relatively small. Based on the current profit and inventory situation of steel mills, the conditions for negative feedback have not been met. The short-term production of molten iron is still at a high level, and the demand for iron ore still supports prices. It is expected that the short-term fluctuations in ore prices will be mainly narrow.

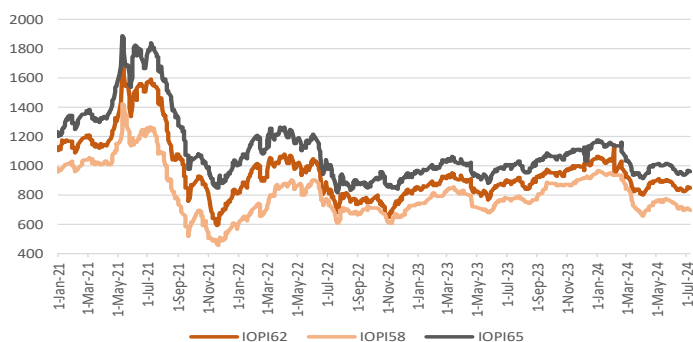

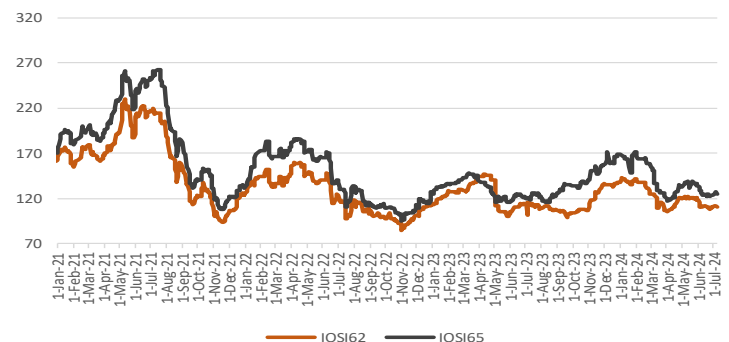
China Mines Concentrate Composite Index RMB/WT

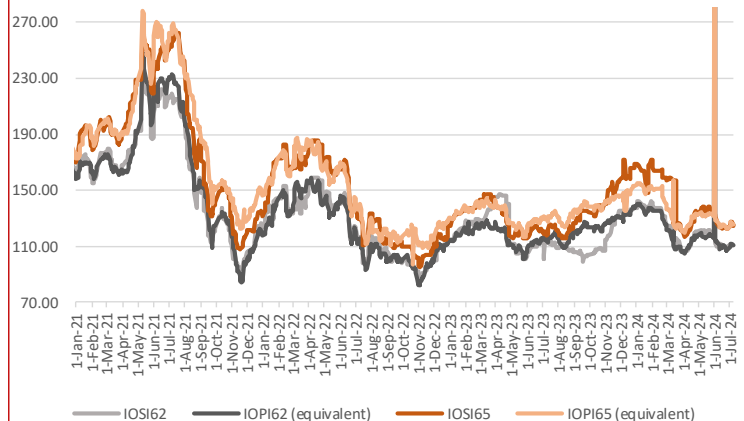

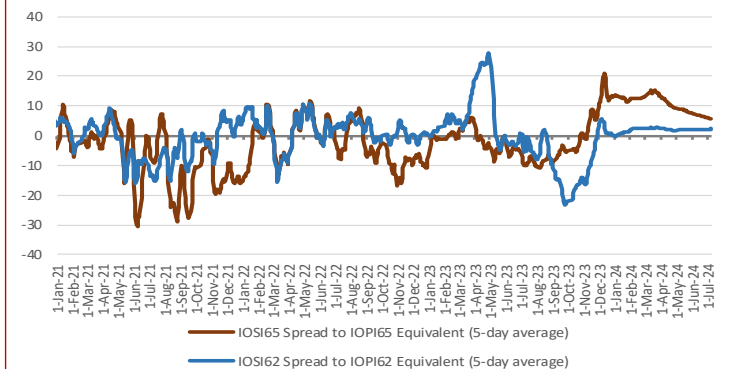

WEEKLY IRON ORE PORT STOCK LUMP PREMIUM (RMB/DMTU)



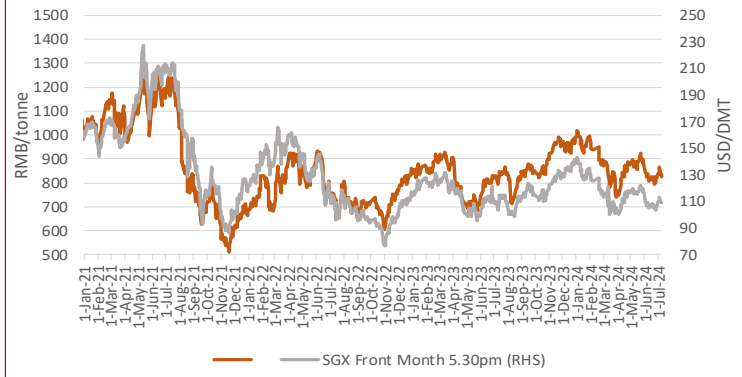
IRON ORE SEABORNE TO PORT STOCK PRICE SPREADS (USD/DMT)

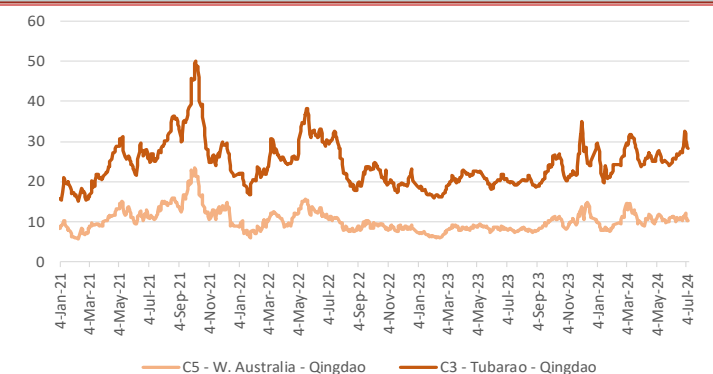

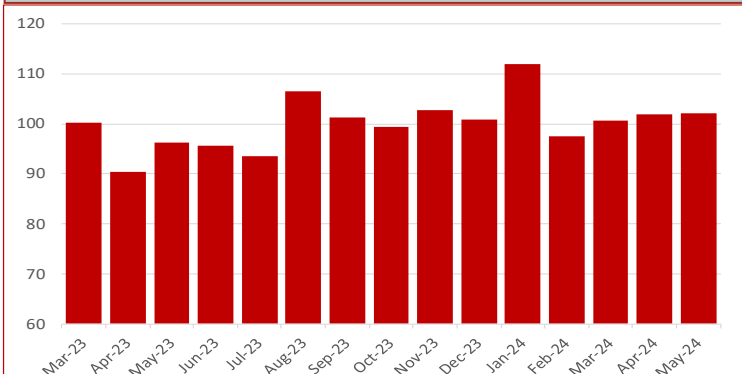

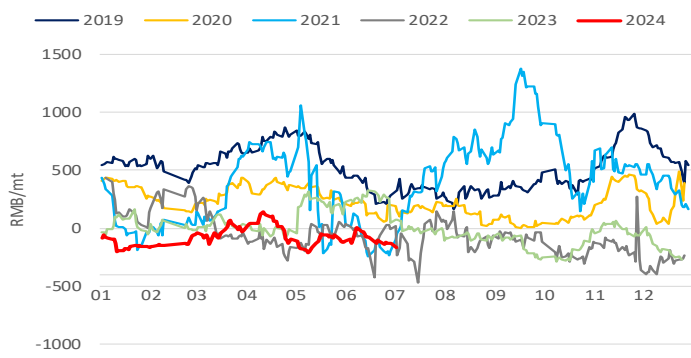

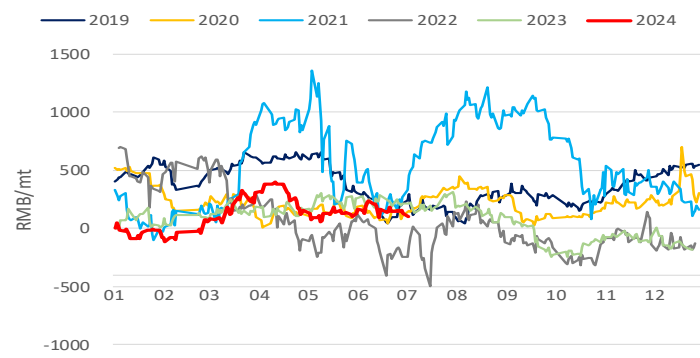
CHINESE STEEL MILL PROFITABILITY



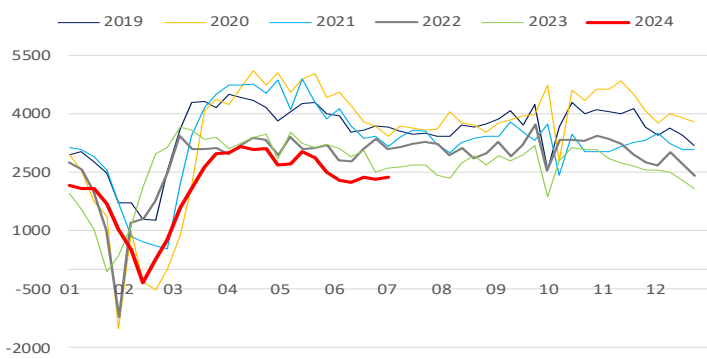
CHINESE STEEL MILL PROFITABILITY—Rebar



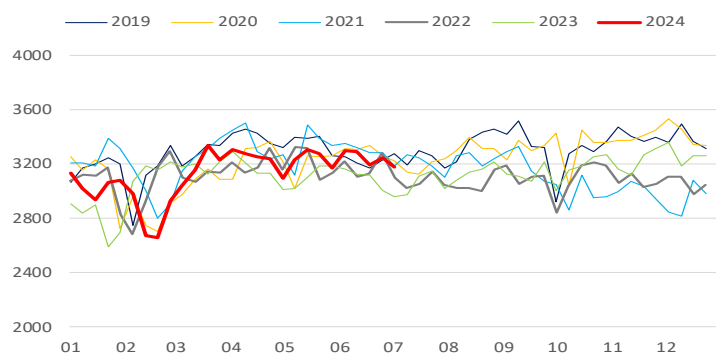
CHINESE STEEL MILL PROFITABILITY—Hot-rolled Coil



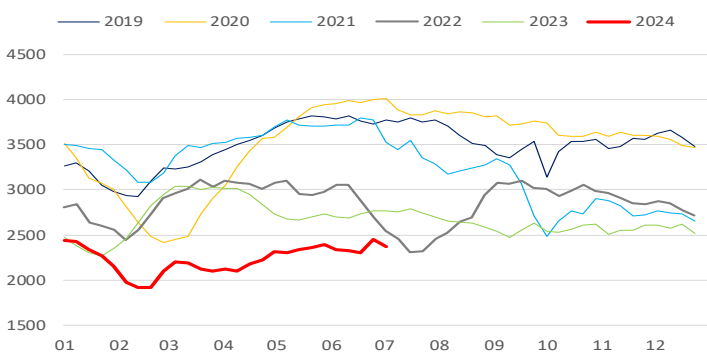
CHINESE STEEL CONSUMPTION—Rebar



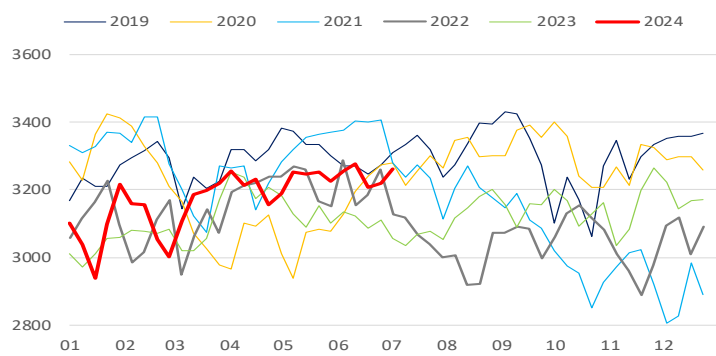

IRON ORE DOMESTIC CONCENTRATE INDEX CALCULATION METHODOLOGY

The compilation method for price index generally refers to the compilation method of CPI price index and other price indices, breakdown the price data and calculate the average value according to a certain method, taking the vertical axis as the regional composite index (average of different grade index) and the horizontal axis as the grade composite index (average of different regional index), a total composite index for domestic ore can be output ultimately. The process system is also adopted in the calculation i.e. each sub-index can be obtained as well.
